Most commercial payors provide no cost sharing for services directly related to COVID-19. In the chart above, the answer “yes” to cost sharing is for telehealth services not directly related to COVID-19.

\*Most commercial payors state self-funded plans could opt out of no-cost sharing for telehealth. And some are subject to if the individual plan covers telemedicine.

\*\* PTs, OTs, and SLPs are not eligible providers for telehealth under Medicare. However, they can report E-visits, patient-initiated online *digital* services for established patients (e.g. online patient portal). They are represented by CPT codes 99421-99423 (0.43-1.39 RVUs) for physicians, physician assistants, and nurse practitioners and CPT codes G2061-G2063 (0.34-0.94 RVUs) for nonphysicians (PTs, OTs, SLPs). Commercial payors may cover certain therapy services under telehealth.
