The NMTCSUSA Team Acquisition Regulation System™ (TARS) contains both NMTCSUSA Team and GSA Contractor Team Arrangement (CTA) acquisition policies and practices, contract clauses, solicitation provisions, managed exceptions, and forms that control the relationship between NMTCSUSA and members and potential members.

In order to fully comply with the rules and policies set forth in FAR 9.6 Contractor Team Arrangement and other Federal, State, and Local regulations and agreements, there needs to be a single source repository that both the Ordering Activity and Team Members can access. Critical to the governance of innovation in a Team environment is process. Our understanding of the nature of

procurement and strategic sourcing coupled with the inherent competitive nature of business ownership, marries risk with transparency. As we as a collective establish how each Team Member will bring their core competencies to bear to solve complex government issues we will work to manage and monitor performance and completion along each requirement phase.

TARS will over time become a strategic vehicle to facilitate Team formation and client assurance for our members across the globe.

The 8(a) Streamlined Technology Application Resource for Services (STARS) II Governmentwide Acquisition Contract (GWAC) – “8(a) STARS II”, a/k/a “STARS II”, is a Multiple Award (MA), Indefinite-Delivery, Indefinite-Quantity (IDIQ) contract to provide information technology (IT) services and IT services-based solutions which may include the integration of ancillary support which is necessary and integral to the IT services being acquired. STARS II is reserved for qualifying Small Business Administration (SBA) certified 8(a) prime contractors with competitive prices. The scope of the contract will be based on four Functional Areas (FAs), each grounded in one of four NAICS codes and their respective definitions.

FA1:NAICS 541511 -Custom Computer Programming Services

FA2:NAICS 541512 -Computer Systems Design Services

FA3:NAICS 541513 -Computer Facilities Management Services

FA4:NAICS 541519 - Other Computer Related Services

The National Minority Technology Council is exclusively working to provide Contractor Team Arrangements that include an Alliance Partnership made up of STARS II Industry Partners. This allows NMTC an opportunity to work with a pre-selected group of minority ICT vendors who encompass both the STARS II contract and who also have a GSA Schedule 70 Contract with the Federal Government.

NMTC is in negotiations with State, Local, Higher Education, K-12, NGO, Commercial and International (Including Countries) buyers. Our IMPACT Initiative outreach and vendor governance process qualifies minority ICT vendors. We will allow for subcontract vendor relationships with NMTCUSA's STARS CTA Alliance as agreed by both GSA schedule holders and ordering activity..
