

## **CONTEST RULES PDPAOLA + WORLDTRIP**

The participation in the Worldtrip give-away implies the complete acceptance of the promotional bases detailed below, (henceforth "bases").

### **I.PROMOTERS/ORGANIZERS**

The give-away (hereinafter the "promotion") which will be held in the Spanish State under the following Bases, will be organized by the mercantile SASMAT Retail, S.L. (PDPAOLA) (hereinafter, "promoter"), of Spanish nationality, with registered office in C/Joaquim Molins 5, 4º 4th 08028 Barcelona and CIF B55670228 number.

### **II.PARTICIPATION**

This promotion will have international scope, with free and voluntary participation, and those under 18 years of age being excluded from the present promotion. The Promoter reserves the right to request documentation to the participants to prove they are the minimum age required to participate in the promotion.

To participate in the Worldtrip give-away, the interested parties must make a purchase in one of the following locations exceeding €50 (PVP VAT included, and, where applicable, shipping costs included): P D PAOLA website (the minimum amount of 50 € is not required); any own physical store (located in the Diagonal Mar shopping Centre and La Maquinista), or in any authorized center. To participate they must also register with their full name and email to the website worldtrip.pdpaola.com and send a picture of the purchase ticket to help.pdpaola.com with the subject "Worldtrip participation".

Every purchase in each of these channels will represent a participation in the give-away. The promoters reserve the right to exclude, without prior notice, all those persons who make fraudulent use and contrary to the good faith of the promotion and the present Bases.

The requirements for a correct participation in each location will be the following:

- Website [www.pdpaola.com](http://www.pdpaola.com): The participant must make an uncanceled purchase within the period indicated below. In case of canceling the purchase, the participation will be automatically cancelled.
- Own shops P D PAOLA and authorized centers: The participant must make an uncanceled purchase within the period indicated below. The minimum purchase to participate in the give-away is €50 VAT included. In case of canceling the purchase, the participation will be automatically cancelled. In this channel, the store staff will inform all customers of the existence of the promotion and take the necessary data for the participation (name, surname, email and telephone number of the participant)

### III. DURATION

The participation in the promotion will begin on November 29th, 2017 and end on December 21<sup>st</sup>, both inclusive. Any participation formalized after the date of completion will not be considered valid. The winner of the give-away will be announced on January 2nd, 2018 through a post on the website: [worldtrip.pdpaola.com](http://worldtrip.pdpaola.com) and through a personal email to the winner of the give-away. The name of the winner will be publicly communicated, although no personal details or contact information will be published, except of their name and surname.

### IV. PRIZE

The prize consists of a roundtrip plane ticket for 2 persons, to any destination chosen by the winner. The departure will be made in any case from the nearest international airport of the usual domicile of the winner and without any prejudice regarding the nationality of the contestant. The duration of the trip shall be no longer than 15 days, including the days of the round trip, and the maximum value of the tickets is €1200 per person. The dates of the trip will be chosen by the winner, although there must be a minimum of 4 months of time from the reservation of the tickets to the date of the first flight.

For more expensive routes, the winner will have the right to pay the difference between the maximum value of the prize and the actual cost of the tickets. In any case, the tickets will be in "Tourist" class.

This prize shall in no case be subject to change, alteration or compensation in cash at the request of the winner, nor may it be subject to change, alteration or compensation for other products. The waiver of the prize shall not grant entitlement to compensation or compensation. The winner will be able to travel from September 2018 onwards.

If for reasons outside the promoter, the prize could not be given, the Promoters reserve the right to replace the prize for another of equal value.

### VI. DELIVERY OF THE PRIZE

The promoter will contact the awardee to inform him of his winning status via electronic mail, contacting them to the electronic address provided at the time of participation. The winner must, within 15 working days, answer the email accepting or not the prize and indicating its personal data. From the acceptance of the award, the Promoter will deliver the prize within a maximum of two months, the necessary amount of time to arrange the flights between the two parties.

If the winner does not accept or does not answer within the deadline established on the email, he will not be able to opt for the prize. In this case, it would lose its status as a winner in favor of the first reserve chosen in the give-away, starting again the prize delivery procedure described in the paragraphs above.

In any case, the Promoter reserves the right to declare void the prizes on justified grounds or due to force majeure.

## VII. DATA PROTECTION POLICY

The information provided by the participants will be included in a file owned by PDPAOLA, responsible for the processing. This information will be treated in accordance with the legislation in force of the protection of personal data.

PDPAOLA, as responsible for data processing, guarantees the confidentiality of personal data provided by participants and their automated treatment in accordance with the organic law 15/1999 on the protection Personal Data (LOPD, for its Spanish abbreviation) of December 13th and this data protection clause.

In order to protect the rights of the participants in the promotion, under the legal regulations so that protection of personal data and, in particular, to comply with the provisions of organic Law 15/1999, every participant is informed and consents the incorporation of its personal data registered in the existing files owned by PDPAOLA and the automatized treatment to which will be submitted.

The collection and processing of personal data has the following purposes:

- To manage the promotion proposed in these bases.
- The prize-giving and acceptance by the winning participants.
- Obtain data from persons interested in PDPAOLA's products and services to periodically send them promotional information, including electronic means.
