

Terms and Conditions

1. QUOINE Pte Ltd (the “Organiser”) reserves the right to cancel or amend QUOINE Community Voting (the “Event”) or Event Rules at its sole discretion.
2. For the period from 10:00AM 24/7/2018 to 10:00AM 6/8/2018 GMT+7 (‘Round One’), and 10:00AM 7/8/2018 to 10:00AM 20/8/2018 GMT+7 (‘Round Two’) to take part in this Event, all participants must have a live, KYC-verified trading account with QRYPTOS and hold at least 100 QASH in his/her QRYPTOS QASH wallet.
3. By entering the Event, you represent you have read, understood and agree to be bound by these terms and conditions of entry and you acknowledge and agree to be legally bound by these terms and conditions and the decisions of the judges and Organiser without limitation or qualification. You further agree that all decisions of the judges and Organiser shall be final and conclusive.
