What you need to know...

We invoice on 1 July for the financial year ahead and supporters who join throughout the year will be offered a pro-rata rate. The supporter fee is based on your individual annual fundraising revenue (excluding any government grants).

All campaign fees will be used exclusively for the Include a Charity campaign and activities.

The organisation confirms that it has agreed to support Include a Charity by paying the Annual Subscription fee for a period of three years with effect from the date of signing this form. Annual invoicing will occur in June for each financial year.

If the organisation's annual fundraising revenue increases or decreases to the extent that the organisation no longer satisfies the eligibility criteria for the current Band, the organisation undertakes to notify Include a Charity of its revised annual fundraising revenue within 1 month of publishing annual report.
