

# Terms & Conditions

Please read these Terms carefully. These Terms (the "Agreement") should be read by you (the "User" or "you") in its entirety prior to your use of Belotto (the website and the game together referred to as "Service"). ## Definitions

Bitcoin (BTC): Decentralized Cryptocurrency accepted by Belotto.io

Ethereum (ETH): Decentralized Cryptocurrency accepted by Belotto.io

Credits: User's balance, the amount User has available for betting (Purchase Lotto Tickets).

Game: The lotteries, managed by Belotto and provided at Belotto.io website.

Demo: a Virtual version of the Game, which allows User to try playing without placing real bets.

Minimum deposit: Minimum amount, that is recommended to be deposited by the player.

Prohibited Jurisdictions: Territories or states, where online gambling is not permitted or restricted.

Prohibited Use: Prohibited by this Terms & Conditions and applicable legislation actions in regards to the Belotto.

Service: Providing access to the Game managed by Belotto within the Website.

Ticket: Certified that gives the holder a specific right, specifically to claim the prizes on Belotto.

User/Player: Individual, who uses Service and agreed to the Terms of Use.

Website: Website of Belotto located at Belotto.io

Website content: All the text, graphics, video, sound, software and other elements of Website and the Games.

## Grant of License

Subject to Terms & Conditions contained herein, Belotto grants the User a non-exclusive, personal, non-transferable right to use the platform on his/her computer or another device (including Mobile) that has Internet to access the games available and described on Belotto Website.
