# **Terms & Conditions - Accuracy Unlocked**

The company BeMyApp, a French company with a capital of 1.250,00 euros, whose registered office is located 18 Boulevard Michelet, 13008 Marseille, France - company registration number B 523 824 258 (Marseille RCS) - is organizing on behalf of the company Deutsche Telekom AG, a Germany-based company whose registered office is located Friedrich-Ebert-Allee 140, 53113 Bonn, Germany (hereafter referred to, collectively, as "Organizer") an Acceleration Program called "Accuracy Unlocked" (hereafter referred to as "Program or Acceleration Program") from March 4th to August 11th.

# **ARTICLE 1 – ELIGIBILITY**

This Program is intended for participation only by residents of UK, France, Belgium, Netherlands, Luxemburg, Germany, Austria, Switzerland, Sweden, Denmark and Northern Italy shall be construed according to, and governed exclusively by the law applicable in the Organizer's country.

This Program is not open to participants who are not legal residents of one of the eligible jurisdictions at the time of entry or who otherwise do not fall within the eligibility requirements set forth in these T&Cs below.

No purchase necessary to enter or win.

"Accuracy Unlocked", (hereafter referred to as the "Program" or "Acceleration Program") is offered and open only to legal residents of the Eligible Jurisdictions (a) who at time of entry are 18 years of age or older and at least the age of majority in his or her jurisdiction or residence, (b) have agreed to participate in the Acceleration Program, and agreed to these T&Cs, by providing all required information and registering on accuracy-unlocked.hubraum.com; (c) individuals/ start-ups/ companies; and (d) who improve their existing applications/products with GNSS Positioning and create a use case to be found at accuracy-unlocked.hubraum.com.

Employees, consultants, officers and directors of Deutsche Telekom, Hubraum, Swift Navigation and BeMyApp, and employees, contractors, officers, and directors of other organizing entities (collectively referred to herein as the "Program Entities"), and their immediate family members (spouse, siblings, children, and parents) and those living in the same household as such individuals (whether or not related) are not eligible to enter.

This document sets out the terms and conditions (T&Cs) for participation in the Program. In addition, participants shall be required to enter into the following additional agreements: (i) Swift Starling and Skylark Evaluation Agreement (software licence), (ii) <u>Testing and Evaluation Agreement</u> (loan of hardware) and (iii) Investment Option Agreement, (all agreements hereafter collectively referred to as **Programme Agreements**)

It is a condition of participation in the Programme that the participant enters into all four of the Programme Agreements. Each agreement shall be standalone in respect of its individual subject matter and collectively these Programme Agreements form the entirety of the understanding between the Participant and the Programme Organizer.

## **ARTICLE 2 – PROGRAM PHASES**

The program starts on March 4th and ends on August 11th ("Program Period"). All times referenced herein are CET. A selection phase will follow where max 20 teams will be invited to a selection interview. Thereafter, the organizer will choose the top 10 teams to move on to the acceleration phase. Between April 26th and May 10th, Deutsche Telekom will ship devices to the chosen teams. The supply of the Devices shall be subject to the Device Supply Agreement, the terms of which are deemed incorporated into these Terms and Conditions. Every team must deliver a roadmap with individual touch points throughout the program by May 10th. The acceleration program will end with a pitch in front of a panel of experts. There are two possibilities to pitch in front of the panel, the first one is on July 14th. For the teams who did not finish their use case before July 14th, there is a second chance to pitch in front of the panel of experts on August 11th.

## **ARTICLE 3 – APPLICATION PROCESS**

This Program reaches out to companies and start-ups with knowledge and experience in the GNSS technology. The companies/start-ups should have an existing product or one currently in development that could be improved with precise positioning. The goal is to create a use case around this technology.

Every person/start-up/company wishing to participate can apply online on the dedicated website for the Program accessible at the following address: accuracy-unlocked.hubraum.com. It is required that every individual participant or one member per start-up/company is applying. Nonetheless every applicant (individuals and in a team) must provide the following information: last name, first name, date of birth, address, phone number, email and their profile for the purpose of the Program, as suggested on the website. This information is required for the completion of their application.

Each candidate guarantees that the information entered during his/her application to the Program is complete and accurate. Any false, incorrect or incomplete information will automatically result in the application being rejected.

You may enter as many unique applications as you like. The same application cannot be entered into this Program more than one time, or by more than one Participant, and in such an event, all Participants and all Entries may be disqualified.

The Organizer reserves the right to reject an application at any time if the profile of the Participant does not comply with the Program standards.

Program Entities assume no responsibility for lost, late, incomplete, inaccurate, stolen, misdirected, or illegible entries; nor for any computer, telephone, cable network, electronic or Internet hardware or software malfunctions, failures, connections, or availability, or garbled, corrupt, or jumbled transmissions; nor for service provider, Internet, web sites, user net accessibility or availability, traffic congestion, or unauthorized human intervention or any technical error; nor for unauthorized human intervention, human error, or the incorrect or inaccurate capture of entry or other information; nor for the failure to capture any such information.

Participation in the Program is subject to the Participants entering into all four Programme Agreements as described in Article 1 above.

### ARTICLE 4 – ENTRY WARRANTY

By entering this Program, each Participant hereby represents, warrants and agrees to produce written evidence of such if requested, that: (i) The Entry, in whole and in part (the "Entry" shall include any materials provided in connection with the Entry), does not violate or infringe upon any third party rights, including proprietary or intellectual property rights such as copyrights, trademarks, patents, trade secrets, personal or moral rights, or any other rules or regulations;

- (ii) The Entry, in whole and in part, is submitted to the Program by or with the permission of all persons (living or deceased), venues and/or entities who worked on, were engaged to work on, or contributed in any respect to the Entry or any part thereof, who are depicted (directly or indirectly) in the Entry by name, likeness, voice, image or any other information or indicia of persona, or who otherwise have any right, title and interest in and to the Entry or any part thereof (including but not limited to rights arising from a work for hire relationship), and all such persons, venues, and/or entities have provided their written consent to submission of the Entry and its use pursuant to these Terms and Conditions;

## ARTICLE 5 – SUBMISSION REQUIREMENTS

Submissions will only be accepted from an eligible individual with full rights to do so, either on his/her own behalf, or on behalf of his or her start-up/company (each is referred to herein as a "Participant" or "Entrant"). Companies must appoint one individual for contact. By submitting an Entry on behalf of a company, Entrant affirmatively agrees that he or she has been asked to do so on behalf of the company.

As between Competition Entities and Participant, Participant has and retains all intellectual and proprietary rights in and to the Entry that Participant had at the time of submission to this Program. By entering, each Participant acknowledges and expressly agrees that his/her Entry may be promoted by the Program Entities on its website and/or in various media (including via paper, data and digital media) at the Program Entities' discretion.

#### ARTICLE 6 – SELECTION CRITERIA

The Program Entities may invite applicants for an interview. There are two different times where interviews can be conducted. The first one will be done on Wednesday, April 21st and the second time will be done on Thursday, April 22nd. If you/your start-up/company are chosen for the interview, you will be contacted on April 16th to choose a suitable time slot. After the second interview day, the top 10 teams will be chosen to take part in the Program. The teams will be announced on Friday, April 23rd.

Teams will be selected by following these criteria:

- 1. Company Size
- 2. Feasibility
- 3. Scalability
- 4. Fit to Deutsche Telekom
- 5. Commercial Target
- 6. Company Aim

Scores will not be made public by the Organizer at any time. By accepting these T&Cs and taking part in the acceleration phase, the teams consent to the publication of their names on any of the Program Entities' websites and in other publications in all forms of media.

# **ARTICLE 7 – PRIZES**

All teams participating in the acceleration program may receive the following:

- One (1) Precision GNSS Module (PGM) Evaluation Platform—featuring Swift Navigation's mPCle format PGM receiver installed in an IoT compute platform (which is yours to keep for prototyping and evaluation purposes)
- Free access to the cloud service for the remainder of 2021
- Communication and promotion of the program and the use cases by hubraum, Deutsche Telekom and Swift Navigation.
- Joint business development opportunity for the most promising use cases
- Investment option from hubraum (separate agreement might need to be signed)

# **ARTICLE 8 - GENERAL**

Participation in this Program is subject to these Terms and Conditions. Participants agree to abide by and be bound to these T&Cs and the decisions of the Organizer, which are final and binding in all respects, as well as the above referenced Privacy Statement. These T&Cs and the referenced Privacy Statement may be amended or varied at any time during the Program by the Organizer at the Organizer's sole discretion, and the Organizer will post the revised terms and conditions at accuracy-unlocked.hubraum.com and email such revised terms and conditions to the email address provided by Participant.
