

## **Terms & Conditions – Orange Network APIs Hackathon**

### **ARTICLE 1 – ORGANIZATION OF THE COMPETITION**

**Orange**, a French société anonyme, with share capital of 10 640 226 396 euros, registered with the Commercial Trade and Companies Registry under the number 380 129 866 RCS Nanterre, having its registered office at 111, quai du Président Roosevelt 92130 Issy-les-Moulineaux, France, for the purpose of this Competition (as defined below) with offices at Orange Gardens, 40- 48 avenue de la République, Châtillon (92 320), France, takes part in the Orange OpenTech 2025 show with, notably, demonstration areas and on-site personnel (hereafter referred to as “**Orange**”).

Orange tailored the Orange OpenTech 2025 event specifically for developers eager to push the boundaries of innovation and organizes upfront the Orange Network APIs Hackathon, a competition where participants are invited to exploit the provided API capabilities to create cutting-edge solutions in a stimulating peer’s environment (the “**Competition**”).

**BeMyApp**, a French société par actions simplifiée, with share capital of 1.250 euros, whose registered office is located at 18 Boulevard Michelet, 13008 Marseille, France, registered with the Marseille Commercial Trade and Companies Registry 523 824 258 RCS Marseille, is assisting Orange with the organization of the Competition (hereafter referred to as the “**BeMyApp**”).

### **ARTICLE 2 – PURPOSE OF THE COMPETITION**

The aim of the competition is for Participants to develop, in teams and over a limited amount of time, an innovative solution leveraging the Orange Network APIs available on the Orange Developer’s dedicated webpage : [Network APIs - Orange Developer](#)

“**Orange Network APIs**” are standardized interfaces offering agility, flexibility, and innovation, enabling developers to leverage real-time network data without needing deep telecommunications expertise. Part of the GSMA Open Gateway Initiative and Linux Foundation’s CAMARA open-source project, Orange provides a set of secure and compliant Network APIs across various geographies, empowering developers to build next-generation applications.

Orange expects candidates to integrate one or more Orange Network APIs in a prototyped web or mobile application in the form of a live demonstration, a presentation or a mock-up.

### **ARTICLE 3 – PARTICIPATION PROCESS AND SCHEDULE**

The Competition is free and without any purchase obligation.

The Competition is open to all individuals:

- (i) who have the age required by law in their country of residence to enter this competition,
- (ii) who have IT skills, technical skills, design skills, or marketing skills, and

- (iii) who have their own computer hardware in working order throughout the duration of the Competition.

(hereafter referred to as “**Candidates**”).

Every person wishing to participate to the competition needs to fill in the registration form.

Candidates can register individually or on behalf of their company. Individuals agreeing to the Terms (as defined in Article 15) on behalf of a company, organization, or legal entity represent and warrant that they have the right and authority to act in the name and behalf of such company, organization, or legal entity, to bind such company, organization, or legal entity to the Terms, and to perform fully the obligations under these Terms.

Candidates shall propose projects and may propose teams.

Orange and BeMyApp will select participants among the Candidates based on the use case relevancy, the number of Orange Network APIs involved in the project and the maturity of the prototype (hereafter referred to as the “**Participants**”).

Employees of Orange and BeMyApp and/or their affiliates, and members of their families, as well as anyone who has directly or indirectly contributed to the conception, organization, or realization of the Competition, are ineligible to take part in the Competition.

All Participants to the hackathon will receive an invite to the Orange Open Tech’s developer’s day.

Each registration in the Competition is individual, and only one registration per person is allowed during the entire duration of the Competition.

### **Phase 1: Registration process**

- Dates: 4th of September 2025 until 29<sup>th</sup> of October
- Place: Online. Candidates can register online via the dedicated website for the Competition at the following address: <https://hackathon.developer.orange.com>
- Purpose: Candidates shall provide the following information: last name, first name, address, phone number, email, company, motivation to participate, and their profile for the purpose of the Competition, as suggested on the abovementioned website. This information is required for the completion of their application.

Each Candidate warrants that the information provided at the time of his/her application to the Competition is complete and accurate. Any false, incorrect, or incomplete information will automatically result in the application being rejected.

BeMyApp reserves the right to reject an application at any time if the profile of the Candidate does not comply with the Competition standards.

### **Phase 2: Selection and Teams**

- Dates: 1<sup>st</sup> of October
- Place: Online

Purpose: The profiles of the Candidates registering individually will be reviewed and selected by Orange and BeMyApp.

Candidates can propose their own pre-formed teams of 2 to 5 members. Selected Participants without team will be assigned to an existing team according to their profiles and skill sets. The teams composition will be communicated to them on 1<sup>st</sup> of October at the latest.

A prioritization will be given to startups and team formed of 2 to 5 members.

### **Phase 3: Start of work on the projects**

- Dates: From 1<sup>st</sup> of October to 29<sup>th</sup> of October
- Place: On-line on the <https://hackathon.orange.com> platform
- Purpose: Participants will get access to resources and start working on their solution. Orange will organize an on-boarding webinar to present the APIs and the supporting team on the 1<sup>st</sup> of October. Replay of this webinar will be available on platform for late registrants. Participants will be asked to submit a short description of their project on the platform.

### **Phase 4: Evaluation and presentation of the prototypes**

- Date: On 30<sup>th</sup> of October
- Place: On-line on the <https://hackathon.orange.com> platform
- Purpose:  
Each Team will present its prototype to the jury in the sequence determined by BeMyApp and for a duration which will be determined according to the number of developed prototypes and which will not exceed 5 minutes, including 3 minutes of demo and 2 minutes of questions/answers with the jury.  
The jury will select the 3 finalist teams that will pitch their project during the Orange OpenTech exhibition.

### **Phase 5: Final pitch, jury's final selection and Competition results**

- Date: On 20<sup>th</sup> of November
- Place: Orange premises or remotely
- Purpose:  
Each Team will present its prototype to the jury in the sequence determined by BeMyApp and for a duration which will not exceed 5 minutes, including 3 minutes of demo and 2 minutes of questions/answers with the jury.  
Jury's deliberation and announcement of winners and prizes.

## **ARTICLE 4 – DETERMINATION OF WINNERS**

The five top list will be ranked by a jury of 3 members representing Orange and other professionals. The composition of the jury will be communicated to the Participants at the latest on 29<sup>th</sup> of October.

The winners will be selected from among the Participants who actually:

- Satisfy the conditions for participation as outlined in the present Terms,
- Participated in the Competition session,

- Were present during the submission of their prototype on 30<sup>th</sup> of October, or – if need be – were excused by the other members of their Team.

The jury will select the winning Teams based on the following criteria:

### **Innovation**

We assess the uniqueness of the idea and the creative use of the CAMARA API capabilities. We especially appreciate unconventional combinations of different API functions and solutions that address real but previously unmet needs.

### **Usefulness**

We evaluate how well the solution addresses real-world problems and its potential impact. Higher scores are given to solutions that effectively meet user needs, improve existing processes, or introduce valuable new functionalities.

### **Scalability**

We analyze the solution's ability to grow and adapt to larger user bases, different markets, or additional functionalities. Solutions with a clear strategy for expansion and technical scalability receive higher scores.

### **Feasibility**

We assess the practicality of implementing the solution, considering technical, business, and operational constraints. Solutions with a well-thought-out execution plan and realistic implementation pathways are rated higher.

### **Quality of the prototype**

Functional prototypes score higher than mere concepts. We evaluate the level and quality of CAMARA API utilization within the project, rewarding efficient combinations of different API functions and their optimal use.

Jury decisions are final and cannot be challenged.

## **ARTICLE 5 – PRIZES AWARDED**

The Competition is endowed with the following prizes:

- **1<sup>st</sup> prize:** Individual passes for the whole team for the Mobile World Congress 26 Barcelona.
- **2<sup>nd</sup> prize:** 3 Individual passes for Vivatech26.
- **3<sup>rd</sup> prize:** 3 Individual passes for APIDays25 Paris.

The three teams will be invited to a test session in Orange 5G Lab with support from Orange experts and mentors to operationalize their prototype.

The gained prizes are not exchangeable. BeMyApp and Orange reserve the right, if circumstances so require, to replace the prizes with others of equivalent value, without liability being incurred thereby.

## **ARTICLE 6 – PRIZE ALLOCATION**

Prizes will be sent by Orange to the winners to the address indicated by the winners.

If the address of a winner is unusable (illegible, incomplete, or erroneous), the latter will lose the profit of its prize.

In addition, Orange cannot be held liable because of an error of routing of the prize, the loss of the prize during shipment, or inability to contact a winner.

## **ARTICLE 7 – COMPENSATION**

Participant waives all of his/her claims regarding compensation against BeMyApp or Orange due to his/her participation to the Competition (in particular with regards to costs incurred for participation such as transport, accommodation, etc.) with the exception of drinks and meals which will be supplied by Orange during the duration of the Competition.

## **ARTICLE 8 – MODIFICATION, INTERRUPTION AND TERMINATION OF THE COMPETITION**

BeMyApp and Orange shall not be deemed to have failed in their obligations hereunder and will not be liable for damages if the performance of the Competition or its content are amended, shortened, cancelled, delayed or modified, in whole or in part, by an event of force majeure or any cause beyond BeMyApp and/or Orange's control. Is considered as a case of force majeure, any fact or event that meets the definition of the French Civil Code or that has been considered as such by a court.

In such case, BeMyApp will provide notice thereof to the Participants by any means of its choice (including email and/or publication on the Website), and, if the need arises, will communicate to the Participants the new rules applicable or the new ending date of the Competition, as the case may be. Each Participant may notify BeMyApp by email that she/he refuses the new conditions of the Terms, in which case s/he will be excluded from participating, which s/he expressly accepts. If no refusal is communicated to BeMyApp within 72 hours, the new conditions of the Terms will be deemed to have been accepted by Participants.

In case of a modification to the Terms, cancellation or interruption of the Competition, or a reduction or an extension of its length, BeMyApp and Orange waive all liability, and Participants will not be entitled to any compensation.

## **ARTICLE 9 – FRAUD**

BeMyApp and Orange may cancel all or part of participations in the Competition if it appears that fraud has occurred in any form whatsoever, in particular computer fraud, during the Competition. BeMyApp and Orange reserve, in this case, the right not to award prizes to fraudsters, to disqualify the concerned prototype project and/or to bring actions against the authors of these frauds. BeMyApp and Orange shall not incur any responsibility towards the Participants because of the committed frauds.

Furthermore, BeMyApp and Orange cannot be liable in case of damage, whether material or immaterial, caused during the Competition and thereafter, to the Participants, to their

computing equipment, or to the data, including consequences which may ensue from it on their personal, professional or commercial activity.

## **ARTICLE 10 – EXPLOITATION RIGHTS AND INTELLECTUAL PROPERTY**

Exploitation and property rights to prototypes developed during the Competition are reserved to Participants.

If the Participants wish to assign their rights, they shall first offer to BeMyApp the option to acquire the rights in their prototypes for commercial use. The conditions of this assignment of rights shall be defined by way of a separate agreement between BeMyApp and the Participants.

During the Competition, the Participants shall only use elements which are clear of any rights. Any third-party elements included in the prototype, including open-source software, must be clearly identified with their version, the terms of the applicable license and any other details regarding their use. The Participant understands that this information is taken into account in the assessment for the allocation of a prize.

The prototypes shall not infringe any intellectual property right or images right. Each Participant warrants to BeMyApp and Orange that their creation does not infringe in any way any third-party rights, and that s/he obtained, where necessary, the authorization of any third party.

By joining the Competition, Participants expressly authorize BeMyApp or Orange, for free, to publish, communicate, exhibit and disclose orally, graphically or in writing, projects and prototypes presented during the Competition. Each Participant agrees to be mediatized (portfolio, website, etc.) and authorizes BeMyApp or Orange, for free, to present all the works realized on all the communication media used in support of this Competition as well as to mention names, first names and images of the Participants.

Under this regulation, the Participant shall not acquire any full or partial right of any kind on the name and trademark “Orange” nor on any names and/or brands associated with Orange, used alone, in association with or as part of another word or name, or any rights on trademarks, names or logos of Orange, or any of its associated or related companies.

## **ARTICLE 11 – IMAGE RIGHTS**

The Participants may be filmed or photographed during the Competition. By joining the Competition, the Participants agree to the use and the distribution of their image by BeMyApp and/or Orange, including for promotional events occurring after the Competition. The production and distribution of films and photographs of the Competition will not lead to any compensation of the Participants.

## **ARTICLE 12 - CONFIDENTIALITY**

The Participant acknowledges the confidentiality of all information and documents which have been shared with him/her throughout the Competition.

During the whole duration of the Competition, the Participant will not directly or indirectly use or share any information with any third party, unless s/he has obtained a written authorization

to do so, delivered by BeMyApp beforehand. This applies to information shared with him/her by BeMyApp or shared with him/her indirectly upon the execution of these Terms.

The Participant commits to delete or destroy any document containing confidential information or shared with the Participant upon the acceptance of these Terms, on BeMyApp's simple request. This confidentiality agreement is valid for 24 months from the end of the Orange Network APIs Hackathon as defined in Article 3.

## **ARTICLE 13 – PROTECTION OF PERSONAL DATA**

Orange, acting as Data Controller, processes Participants' personal data when they participate in the Competition. The processing of personal data of Participant(s) by Orange is primarily intended to ensure that the Competition will be properly completed and to select the candidates, provide the necessary support and send invitation to the Orange Open Tech event.

Orange has engaged BeMyApp as Data Processor to assist with this process. The collection and processing of personal data relating to the Participant by BeMyApp is primarily intended to ensure that the Competition will be properly completed and to allow BeMyApp to contact the winner and, if the case arises, to publish the list of the winners. BeMyApp will process your personal data on Orange's behalf and in accordance with Orange's instructions.

By registering for the Competition, the Participant consent to the collection and processing of his/her personal data as described in the attached Privacy Notice.

The personal data collected are:

- identification data (last name, first name, e-mail, and phone number, company ...),
- motivation of the Participant to participate in the Competition.

Participant's personal data will be used solely for the purposes of managing the Competition and will be handled in accordance with the General Data Protection Regulation (GDPR).

## ARTICLE 14 - RESPONSIBILITY

BeMyApp reminds Participants about the characteristics, limitations and risks of the Internet network and accepts no responsibility for any consequences that may occur while they are connected to the event websites and during their participation in the Competition.

BeMyApp and Orange shall not be made responsible if Participants cannot connect to the website of the event due to a technical fault or in the event of any problem linked namely and not exclusively to (1) network overload ; (2) an electric or human error (3) any malicious intervention ; (4) an issue related to a phone line ; (5) an issue related to hardware or software ; (6) a hardware or software malfunction ; (7) a case of emergency ; (8) disruptions that may affect the smooth running of the Competition.

It is the Participant's responsibility to take the appropriate measures to protect his/her own data and/or software located on his/her computer equipment, against any violation. The Participant's connection to the event websites and their participation in the Competition is made under their own sole responsibility. BeMyApp and Orange shall not be held responsible for any infection by potential viruses on the Participant's computer equipment, or of the intrusion of a third party on their system.

BeMyApp shall not be held responsible if, for any reason, data related to a Participant's registration doesn't reach the company or is illegible or impossible to process.

BeMyApp and Orange reserve the right to exclude any Participant or person disrupting the Competition's smooth running. In case of failure to reach an amicable settlement, the parties submit to the exclusive jurisdiction of the Paris courts to decide and settle any claim, dispute or matters arising out of or in connection with the Terms or established by them (whether contractual or non-contractual).
