

Ethics in the Pandemic: Teacher Resources

The COVID-19 pandemic is a threat to tens of millions of people, and the medical and public health priorities are clear: prevent the virus' spread and care for those who are affected. But combating the disease also raises a host of ethical questions about medical triage and rationing care, politics and preventive measures, the integrity of medical research, medical misinformation, and more.
