

- A. <u>Liquid supplements stored in re-circulating tank systems:</u> Re-circulate immediately prior to use moving no less than 1 percent of the tank contents per minute from the bottom of the tank to the top for not less than 10 minutes. Re-circulate daily, as described above, even when supplement is not used.
- B. <u>Liquid supplements stored in mechanical, air or other agitation-type tank systems:</u> Agitate immediately prior to use for not less than 10 minutes, creating a turbulence at the bottom of the tank that is visible at the top. Agitate daily, as described even when supplement is not used.

 - e. Animals must have consumed other feed prior to being given this Liquid Feed Supplement for the first time. Do not provide overly hungry animals free access to this Liquid Feed Supplement.
 - f. If animals are not fed a Liquid Feed Supplement for 48 hours, observe animals closely for three days to prevent overconsumption.
 - g. Provide a free choice mineral supplement containing adequate levels of calcium, phosphorus, salt, and trace minerals.
