

Official Contest Rules

1. DESCRIPTION: NO PURCHASE NECESSARY TO ENTER OR WIN. The "FUNDRAISER ACROSS AMERICA" ("Contest") begins at 12:01 PM (PT) on Monday, April 9, 2018 and ends at 11:59 AM (PT) on Saturday, June 30, 2018 ("Contest Period"). The Sponsor(s) of this Contest is Bonvee / Mixed Bag Fundraising, Inc. ("Sponsor"). The administrator of this Contest is Visionworks ("Contest Administrator").

2. ELIGIBILITY: Contest is open to legal residents of "THE 50 UNITED STATES" who are at least ten (10) years of age at time of entry and who have internet access as of April 9, 2018. All entrants must be registered in compliance with Sponsor Terms & Conditions policy located at

[http:// learnmore.mixedbagdesigns.com/FundraiseAcrossAmerica](http://learnmore.mixedbagdesigns.com/FundraiseAcrossAmerica) for valid entry. Any individuals (including but not limited to employees, consultants, independent contractors and interns) who have, within the past six months, held employment with or performed services for Sponsors, Contest Administrator (collectively, "Contest Entities") or any organizations affiliated with the sponsorship, fulfillment, administration, prize support, advertisement or promotion of the Contest are not eligible to enter or win. Immediate family and household members of such individuals are not eligible to enter or win. Once entered you will have the opportunity to participate in the Contest All entries must be received by 11:59 AM [PT] on June 30, 2018. Limited to one registration per participant. Entries generated by a script, macro or other automated means will be disqualified. Each entrant must be the rightful owner (or have authorized use) of the email account identified in the entrant's entry as of April 9, 2018. In the event of a dispute as to the identity of a winner, the winner will be deemed to be the person in whose name the email account was opened. Entrants must provide all information requested to be eligible to win. Incomplete, unreadable, or unintelligible entries will be disqualified. All information provided by entrants becomes the property of Sponsor.

limit the number of entrants whose Material is posted on the mixed design website and to remove entrants whose entries have already been posted in the event of an error or determination that the entrant is ineligible to participate in the Contest. You understand that your name and other Materials may be posted on the mixed design website in connection with Contest.

4. **CONTEST CRITERIA:** After registering correctly all entrants will have the opportunity to participate; in one of 12 ways; (a) each week (for 12 weeks) selling a minimum of three (3) packages per week. For each week, each entrant will be entered to win one of five prizes for that week. For every three packages confirmed, entrants will receive an additional opportunity to win for that specific week. At the end of each week the program refreshes and the next week begins new with each entrant having the same opportunity to participate and win again. Participants only have to enter once for the duration of the contest but each week begins a new contest and provides a new opportunity to win. All entrants, whether for one week or all 12 weeks, are automatically entered for a opportunity to win the Grand Prize. All decisions and submissions are final on all aspects of the Contest.
