We take all necessary measures to protect your personal data and to comply with the applicable national and European data protection regulations at all times.

This Privacy Policy provides information about how Original Wagner processes your data. It covers both our online and offline data collection activities, including personal data we collect through our various channels such as websites, apps, third party social networks, consumer services, points of sale, events and business contacts. Questions and answers

What are the sources of the personal data that Original Wagner collects?

Tool for reporting compliance concerns (SpeakUp): This tool enables the reporting of compliance concerns and violations of the Act on Corporate Due Diligence Obligations in Supply Chains via a web form or telephone number.

Original Wagner Mobile Sites/Apps: Mobile sites or applications operated by or for Original Wagner, such as smartphone apps, emails, text or other electronic messages: Electronic interaction and communication between you and Original Wagner.

Consumer Service: Communication with our Consumer Service.

Offline registration forms: Printed or digital registration and similar forms that we collect, e.g. by postal mail, at competitions and other actions or events.

Interaction for advertising purposes: Interactions with our advertisements (e.g., if you interact with a third party website regarding one of our advertisements, we may receive information about those interactions).

Business relations: Conducting the contractual relationship with our customers, partners and suppliers.

Data from other sources: Third party social networks (e.g. Facebook), advertising networks (e.g. Google), market research (if feedback is not anonymised), Original Wagner advertising partners, public sources and data we receive about the acquisition of other companies.

What data does Original Wagner collect and how?

Depending on how you interact with Original Wagner (online, offline, by phone, etc.), we collect different types of information from you as described below.

Personal contact information: This includes any information you provide to us so that we can contact you, such as your name, postal address, email address, social network data or telephone number. It also includes contact details of contacts at our business partners.

Demographic Information & Interests: Any information that describes your demographic or behavioural characteristics. Examples include your date of birth, age or age group, gender, geographical location (e.g. postcode), favourite products, hobbies and interests, and household or lifestyle information.

Computer/Mobile Device Information: Any information about the computer system or other technical device you use to access one of our websites or apps, such as the Internet Protocol (IP) address used to connect your computer or device to the Internet, the type of operating system, and the type and version of Internet browser. If you access an Original Wagner website or app through a mobile device, such as a smartphone, the information collected will also include your phone's unique device ID, advertising ID, geological location and other similar mobile phone data.

Website Usage/Communication Information: As you navigate and interact with our websites or newsletters, we use automatic data collection technologies to collect certain information about your activities. This includes information such as which links you click, which pages or content you view and for how long, and other similar information and statistics about your interactions, such as content response times, download errors and time spent on certain pages. This information is collected for analytics and promotional purposes using automated technologies, such as cookies and web beacons, and is also collected through the use of tracking technologies by third parties. You have the right to object to the use of such technologies, for more details see question 'Cookies (Tracking Technology) - How and why are they used by Original Wagner?'.

Market Research & Customer Feedback: Any information you voluntarily provide to us about your experience of using our products and services.

Content that is created by the consumer: Any content that you create and then provide to us on third party social networks or by uploading to any of our websites or applications, including the use of third party social networking applications such as Facebook. Examples include photos, videos, personal stories or other similar media or content. Where permitted, we collect and post consumergenerated content in connection with a variety of activities, including contests and other promotions, community features of websites and third-party social networks.

Third-party social network information: Any information that you publicly share on a third-party social network or on your profile on a third-party social network (e.g. Facebook) and that you allow the third-party social network to share with us. Examples include your basic account information (e.g. name, email address, gender, birthday, current location, profile picture, user ID, friends list, etc.) and any other additional information or activities that you allow the third-party social network to disclose. We obtain your profile information from third-party social networks (or parts thereof) each time you download or interact with an Original Wagner internet application on a social network, such as Facebook, each time you use a social networking feature embedded in an Original Wagner website (such as Facebook Connect), or each time you interact with us through a third-party social network. If you would like to learn more about how your information is obtained from an Original Wagner social

network, or if you do not wish to have such information shared, please visit the website of the relevant third party social network.

Communication with the consumer service: Telephone communication with the consumer service may be recorded or intercepted in order to meet local operational requirements (e.g. for quality or training purposes), taking into account the legal requirements for this. Payment card data is not recorded here. Where required by law, you will be informed of such recording at the beginning of your call. In addition, we record the data from the telephone call that is necessary for the further processing of your request. Furthermore, we record all information that you provide to the consumer service via other channels such as emails, WhatsApp or LiveChat in order to be able to carry out the communication you have requested.

Sensitive personal data (special categories of personal data): We process sensitive personal data that you provide to us (e.g. week of pregnancy, allergies) for marketing purposes only with your explicit prior consent. If we process your sensitive personal data for other purposes, we rely on the following legal bases: (i) detection and prevention of crime (including fraud prevention); and (ii) compliance with applicable law (e.g. to comply with our diversity reporting).

Information from the compliance concern reporting tool (SpeakUp): The information you provide to us through this will be kept strictly confidential and will only be made available to those persons who need it to investigate the matter and who have been bound to the strictest confidentiality.

How does Original Wagner protect your personal data?

Original Wagner takes all necessary measures to maintain the confidentiality of your personal data and to protect it. Only authorised employees of the responsible company within Original Wagner have access to your personal data. All Original Wagner employees have been required to comply with the Original Wagner Privacy Policy.

If necessary, authorised employees of our service providers, who process the data on behalf of the corresponding Original Wagner company, also have access to this data. In this case, Original Wagner has concluded a so-called 'order processing contract' with the service provider, with which the service provider has assumed a guarantee for the maintenance of confidentiality and the protection of personal data.

Furthermore, Original Wagner has a secure IT environment to protect your personal data and takes the appropriate measures to prevent unauthorised access.

For what purposes and on what legal basis does Original Wagner use your personal data?

The following sections describe the different purposes for which we collect and use your personal data and the different types of personal data collected for each purpose. Please note that not all of the uses listed below are relevant to each individual.

To whom does Original Wagner disclose your personal data and why?

Original Wagner will not, under any circumstances, provide your personal information to other companies that wish to use it for direct marketing purposes unless you have given us express permission to do so. Furthermore, Original Wagner provides your personal data to the following other entities in strictly limited circumstances:

- Our service providers to assist us with e.g. administration of this website, order processing, payment processing, fraud detection, identity verification, market research, promotions, data analysis, advertising targeting. We have contractually obliged these companies to take the same security measures as Original Wagner with regard to the personal data, to maintain the confidentiality of the data and to process it only on the express instructions of Original Wagner. If required by law, you can obtain a list of the service providers that process your personal data.
- Data collected via meta-products, such as the Like button, the Share button, Facebook
 Connect (register with Facebook) or through cookies or other technologies (in particular

pixels) is also received by Meta Ireland Limited (Meta). In particular, information is collected about your visits to our websites and Facebook pages, your interactions on these pages and the use of the aforementioned Meta products. This enables us to measure the effectiveness of our advertising, improve our marketing practices and helps us to serve more relevant advertising to you. Original Wagner is a joint data controller with Meta for this processing. This means that Original Wagner must provide you with this data processing notice, but you must contact Meta if you wish to exercise your rights in relation to the processing of your personal data. - Credit reference agencies/collection companies, to the extent permitted by law, to check your creditworthiness (in particular for orders with an invoice) or to collect outstanding invoices).
- Governmental authorities if we are required to do so by the requirements of an applicable law.

How can you find out about, check, change, block or delete the personal data you have provided and what other rights do you have?

You have the following rights in relation to your personal data:

The right to information, correction, deletion, restriction of processing, objection to processing and the right to data portability.

In addition, you have the right to revoke your consent to the processing of your personal data in the future.

To which countries will your personal data be transferred and why?

Your personal data may be transferred to other countries if a service provider of Original Wagner is based abroad. In this case, a so-called 'order processing contract' is concluded with the service provider, which ensures that the same level of data protection and data security exists as in the country of origin. This is ensured, among other things, by obliging the service provider to act exclusively on the instructions of Original Wagner and to continuously take all technical measures to protect your personal data to the same extent as in the country of origin.

If personal data is processed in a country outside the EU and the EEA, Original Wagner has ensured the appropriate level of data protection by concluding the standard contract specified by the EU for this purpose or an adequacy decision by the EU Commission for the respective country is available. Cookies, Log Files and Web Beacons ('Tracking Technology')- How and why are they used by Original Wagner?

Our Original Wagner website uses cookies and other tracking technologies under the terms of this privacy policy. If you do not agree with our use of cookies and other tracking technologies in this way, please change your browser settings immediately or stop using our websites.

If you are connecting to the internet on a mobile device, please also check the privacy policy of the specific app you are using to learn more about their specific data processing practices.

Cookies are small text files that are stored on your computer by the website you are visiting. They are widely used to ensure the functionality of websites, to make them more effective or to provide information to the website operator. At the end of this question, you will receive more detailed information on the specific cookies used.

We use cookies to improve the use and functionality of our websites and to gain a better understanding of how visitors use our websites and services offered through them. Cookies help us to customise our websites to meet your personal needs, improve the user experience, receive customer satisfaction feedback and communicate with you in other areas of the internet.

We use the following types of cookies on our websites:

Session cookies: These are temporary cookie files that are deleted when you close your browser. When you restart your browser and go to the page that set the cookie, the website will treat you as a new user.

Persistent cookies: These are cookies that remain in your browser until you manually delete them in your browser or until your browser deletes you according to the time limit set in the cookie. These cookies recognise you as a returning visitor.

Necessary cookies: These are cookies that are absolutely necessary for the functionality of the website. They enable you to navigate the websites and use our website features.

Cookies that provide us with information: These are cookies that we integrate into our websites and that can only be read by our websites. They are also called 'first party cookies'.

We also integrate cookies into ads placed on other companies' websites (e.g. Facebook). We receive information about these cookies when you click or interact with the ad. This is then also called a 'third party cookie'. Original Wagner uses this information to serve you ads that are relevant and interesting to you according to your previous online behaviour.

Cookies that provide information to other companies: These are cookies placed on our websites by our partner companies (e.g. Facebook). They use the data collected through these cookies to anonymously serve advertisements to you on other websites based on your use of this website. For example, if you use a Facebook icon on the website, it will record your 'share' or 'like'. Facebook (as the company that set the cookie) will process this information.

Log files: We collect information using log files that record activity on the website and compile statistics about your browsing habits. These data entries are generated automatically and help us to troubleshoot, improve performance and ensure the security of our websites.

Web Beacons: Web beacons (also 'web bugs') are small strings of code that deliver a graphical image on a web page or in an email to transmit data back to us. The information collected via web beacons includes information such as IP address, as well as information about how you respond to an email campaign (e.g. when the email was opened, which links you click on in the email, etc.). We will use web beacons on our websites or include them in emails that we send to you. We use information from web beacons for a variety of purposes, including, but not limited to, reporting on web page navigation behaviour and determining visitor numbers. As web beacons are a part of the website, it is not possible to opt out of their use, but you can opt out by objecting to the use of the cookie that the web beacons set.

IP addresses: This is a number used by computers on the network to recognise your computer each time you log on to the internet. We store IP addresses to fix technical errors, to ensure the security of the website, to better understand how our websites are used and to better customise the content of the websites to your needs.

As a company, we have also voluntarily submitted to the self-regulation of the German Data Protection Council Online Advertising (DDOW). You can find the self-regulation code that applies to us under the link My cookies. Cookies are transferred to your computer's hard drive by means of your web browser or other programs and are stored there beyond the individual visit to our website.

Make sure your computer settings reflect whether you want to accept cookies. You can set your browser to warn you before accepting cookies or to reject them. Use your browser's help function for more information. You do not need cookies to use or navigate many parts of this website. If you use different computers in different locations, you must ensure that each browser matches your preferences regarding cookies.

- In addition, we use the cookie consent tool of Crownpeak Technology Inc. on many of our websites. This tool makes it visible to you which cookies are used for which purpose and you can decide for yourself whether to accept or reject them. Please note that when you delete your browsing history, your settings will be reset.
- Our website uses Google Analytics as a web tracking tool. You can find all other details here.
- Some websites use the communication tools of the social network Facebook Custom Audiences and Website Custom Audiences. You can find all other details here.

E-Marketing- What is spamming and what is Original Wagner's position on spam mails?

Spamming means sending you unsolicited emails with advertising or marketing material without your consent. Sending emails without consent is illegal in many countries. Original Wagner does NOT send spam emails. Original Wagner itself uses an anti-spam tool to protect employees from spamming. Original Wagner will not use your personal information (including your email address) for direct marketing unless you give us your EXPRESS consent. This is known as the OPT-IN process. Original Wagner will also not provide your information to any other company that may use your personal information to send you spam. How long does Original Wagner store your personal data?

Your personal data will be stored for as long as is necessary to fulfil the purpose for which we received your personal data or to comply with legal regulations (e.g. statutory retention obligations). For example, this means that storage will continue until we have answered a question from you, a competition or the contractual relationship with a business partner has ended and the purpose for further storage of contact persons therefore no longer exists, provided there are no legal archiving obligations to the contrary. If you have given us your consent to store your personal data for marketing purposes, this means that your data will be stored for the duration for which Original Wagner takes marketing measures or until you withdraw your consent. You can revoke any consent you may have given to receive advertising at any time with effect for the future.

What is Original Wagner's position on children providing us with personal data?

We do not knowingly collect or store personal data from children under the age of 18. If we discover that we have inadvertently collected personal data from a child under the age of 18, we will immediately delete that child's personal data from our systems. However, Original Wagner may collect and store personal data from children under the age of 18 directly from their parents or guardians and with their express consent. We also do not knowingly collect and store personal data from children under the age of 18 for specific marketing communication purposes.

Is Original Wagner linked to websites of other companies outside of Original Wagner and what happens to my personal information if such a link is present?

Original Wagner links to other websites to provide you with the opportunity to obtain related and interesting information in connection with Original Wagner. These websites operated by other companies outside of Original Wagner are not under our control or subject to these privacy terms. If you access other websites through the links provided, the operator of those websites may collect your personal information. Please make sure that you agree to the privacy policy of these other

companies' websites before you share any personal information. Original Wagner tries to ensure, as far as possible, that the same measures are taken to protect your personal data for all linked websites of other companies. However, we cannot be held legally or otherwise responsible for the activities of other companies.

Can Original Wagner change the terms of this Privacy Policy?

Original Wagner always keeps these data protection conditions up to date. This means that this document will be adapted to changing circumstances in the data processing of Original Wagner as well as any changes in the legal situation.

We would therefore ask you to inform yourself regularly about changes to these data protection conditions.

What specific terms with legal definitions are used in these Original Wagner Privacy Policy?

- *Personal data* is any data relating to you as a natural person that directly or indirectly identifies you. (On websites, this is usually at least your email address).
- Processing of personal data means any operation performed upon personal data, whether or not by automatic means, such as collection, recording, alteration, transmission, blocking and erasure of such data.
- The responsible body is the company to which the user transmits his or her data (i.e. the Original Wagner company that operates this website and collects your personal data). The relevant company is named in the imprint of the respective website.

1. Information on usage-based online advertising/retargeting

of a search query on Google, which is more likely to match your areas of interest and by the fact that less random advertising is delivered overall. 2. What data is collected?
