MoonJam Powered by Super League

Official Rules

Version 1.0; 4/30/2021

Introduction and Purpose

These Official Rules ("Rules") of MoonJam Powered by Super League Gaming, Inc., a Delaware corporation ("SLG"), apply to each player who enters to play in the event. These rules apply only to official MoonJam play and not to other competitions or tournaments.

1.0 Competition Eligibility

1.1 Association Regulations

Participants in MOONJAM agree to be contacted by Super League Gaming in association with MOONJAM.

1.2 Eligibility Rules

The Tournament is open only to Players in the United States of America.

1.2.1 Disciplinary Status

Players may not have any current disciplinary suspension from the publisher and their affiliated competitions.

1.2.2 Eligible Compliance

Players must have accounts in good standing with their respective publisher and be eligible for online play in order to compete. This same account must be used for the duration of the competition. Players may not change their Username/Gamertag without permission during the competition. Each player must follow the respective End User License Agreements.

1.2.3 Age

As of the start of the event, the play must be 13 or older to participate.

1.2.4 Minehut

Players must have a registered Minehut account in order to participate.

2.0 Prizing

2.1 Squeakee Dino Raffle (July 20 – Aug 20)

For each Bone given to the dinosaur during the concert, players will earn an entry into the raffle, players may earn unlimited entries into the raffle. At the end of the MoonJam Concert, 3 winners will be selected and receive a Squeakee Dino toy. Following the conclusion of the concert the raffle will reset and players can spend the following month completing the Parkour course for entry into a raffle for additional Squeakee Dino toys.

2.2 ASTRO A*Star Hunt (July 20 – July 31)

Players will be able to embark on a scavenger hunt collecting Astro Stars throughout the MoonJam lobby. Each Star collected will earn the player 1 entry to win an Astro Headset. 20 winners will win a special limited edition MoonJam custom Astro A40 Headset, only available through MoonJam! Players are able to collect as many raffle entries between July 20th and July 31st

2.3 Fulfillment

All prizing will be fulfilled within 2 months of the conclusion of the event, or of the respective raffle win. To receive their prize, players must provide SLG with their shipping information.

3.0 Player Commitments and Usernames

3.1 Lateness and Absence

Players who are late or absent during the daily portions of the event & designated schedule as defined by MOONJAM Officials will have no recourse for potential loss of scoring and participation opportunities.

3.2 Username & Guest Account Restrictions

For players who qualify for MOONJAM, Usernames/gamertags may not contain vulgarities or obscenities; or derivatives of products or services that may create confusion.

Players may not compete using guest accounts. All participants must have a unique and valid Steam Account and appropriate access levels to the Steam Network as applicable.

3.3 Name Approval

All Usernames/ Gamertags must be approved by MOONJAM officials in advance of use in play. Unapproved name changes are not allowed under any circumstances. MOONJAM officials have the ability to deny a Username if it does not reflect the standards sought by MOONJAM officials. A player will be notified by an MOONJAM official if their name does not meet the standard and will be allowed to change their name. Players may not change their Usernames on their main account during the tournament. MOONJAM is not responsible for complications or costs that arise as the result of name changes.

4.0 Role of Referees

Referees are SLG officials who are responsible for making judgments on every matchrelated issue, question and situation which occurs before, during, and immediately following match play.

4.1 Referee Comportment

At all times, referees shall conduct themselves in a professional manner, and shall issue rulings in an impartial manner. No passion or prejudice will be shown towards any player, team, or other individual.

4.2 Finality of Judgment

If a referee makes an incorrect judgment, the judgment can be subject to reversal. SLG officials at their discretion may evaluate the decision during or after the match to determine if the proper procedure was implemented to allow for a fair decision. If the proper procedure was not followed, SLG officials reserve the right to potentially invalidate the referee's decision. SLG officials will always maintain final say in all decisions set forth throughout MOONJAM.

4.3 Gambling Prohibition

All rules prohibiting gambling on as found below in Section 9, shall apply to referees without limitation.

5.0 Player Conduct

5.1 Competition Conduct

5.1.1 Unfair Play

The following actions will be considered unfair play and will be subject to penalties at the discretion of SLG officials.

5.1.1.1 Collusion

Collusion is defined as any agreement among two (2) or more players and/or confederates to disadvantage opposing players. Collusion includes, but is not limited to, acts such as:

5.1.1.1.1 Soft Play

Defined as any agreement among two (2) or more players to not damage, impede or otherwise play to a reasonable standard of competition in a game.

5.1.1.1.2 Prearranging

Prearranging to split prize money and/or any other form of compensation.

5.1.1.1.3 Signalling

Sending or receiving signals, electronic or otherwise, from a confederate to/from a player.

5.1.1.1.4 Deliberate Loss

Deliberately losing a game for compensation, or for any other reason, or attempting to induce another player to do so.

5.1.1.2 Competitive Integrity

Players are expected to play at their best at all times within any MOONJAM game or match, and to avoid any behaviour inconsistent with the principles of good sportsmanship, honesty, or fair play.

5.1.1.3 Hacking

Hacking is defined as any modification of the Minecraft game client or server by any player or person acting on behalf of a player.

5.1.1.4 Exploiting

Exploiting is defined as intentionally using any in-game bug to seek an advantage. Exploiting includes, but is not limited to, acts such as: glitches in obtaining items, glitches in Champion, Character, Athlete, ability performance, or any other game function that, in the sole determination of SLG officials, is not functioning as intended.

5.1.1.5 Ringing

Playing under another player's account or soliciting, inducing, encouraging or directing someone else to play under another player's account.

5.1.1.6 Cheating Device

The use of any kind of cheating device and/or cheat program.

5.1.1.7 Intentional Disconnection

An intentional disconnection without a proper and explicitly stated reason (e.g., rage quit).

5.1.1.8 MOONJAM Discretion

Any other further act, failure to act, or behaviour which, in the sole judgment of SLG officials, violates these rules and/or the standards of integrity established by SLG for competitive game play.

5.1.2 Profanity and Hate Speech

A Player may not use language that is obscene, foul, vulgar, insulting, threatening, abusive, libellous, slanderous, defamatory or otherwise offensive or objectionable; or promote or incite hatred or discriminatory conduct, in or near the match area, at any time. A Player may not use any facilities, services or equipment provided or made available by MOONJAM or its contractors to post, transmit, disseminate or otherwise make available any such prohibited communications. A Player may not use this type of language on social media or during any public facing events such as streaming.

5.1.3 Disruptive Behaviour / Insults

A Player may not take any action or perform any gesture directed at an opposing Player, fan, or official, or incite any other individual(s) to do the same, which is insulting, mocking, disruptive or antagonistic.

5.1.4 Abusive Behaviour

Abuse of MOONJAM officials, opposing players, or audience members will not be tolerated. Repeated etiquette violations, including but not limited to touching another player's computer, body or property will result in penalties. Players and their guests (if any) must treat all individuals attending a match with respect.

5.2 Unsportsmanlike Behaviour

5.2.1 Responsibility Under Code

Unless expressly stated otherwise, offenses and infringements of these rules are punishable, whether or not they were committed intentionally. Attempts to commit such offenses or infringements are also punishable.

5.2.2 Harassment

Harassment is forbidden. Harassment is defined as systematic, hostile, and repeated acts taking place over a considerable period of time, or a singular egregious instance, which is/are intended to isolate or ostracize a person and/or affect the dignity of the person.

5.2.3 Sexual Harassment

Sexual harassment is forbidden. Sexual harassment is defined as unwelcome sexual advances. The assessment is based on whether a reasonable person would regard the conduct as undesirable or offensive. There is zero tolerance for any sexual threats/coercion or the promise of advantages in exchange for sexual favors.

5.2.4 Discrimination and Denigration

Players may not offend the dignity or integrity of a country, private person, or group of people through contemptuous, discriminatory, or denigrating words or actions on account of race, skin color, ethnic, national or social origin, gender, language, religion, political opinion or any other opinion, financial status, birth or any other status, sexual orientation or any other reason.

5.2.5 Statements Regarding MOONJAM, Affiliated Game Publisher

Players may not give, make, issue, authorize, or endorse any statement or action having, or designed to have, an effect prejudicial or detrimental to the best interest of MOONJAM or its affiliates, as determined in the sole and absolute discretion of MOONJAM officials.

5.2.6 Player Behaviour Investigation

If SLG Officials determine that a Player has violated the Minecraft or Minehut Terms of Service, or other rules of MOONJAM, SLG officials may assign penalties at their sole discretion. If an SLG official contacts a player to discuss the investigation, the player is obligated to tell the truth. If a player lies to an SLG official creating obstruction of the investigation, then the player is subject to punishment.

5.2.7 Criminal Activity

A Player may not engage in any activity which is prohibited by common law, statute, or treaty and which leads to or may be reasonably deemed likely to lead to conviction in any court of competent jurisdiction.

5.2.8 Moral Turpitude

A Player may not engage in any activity which is deemed by SLG to be immoral, disgraceful, or contrary to conventional standards of proper ethical behaviour.

5.2.9 Confidentiality

A Player may not disclose any confidential information provided by SLG or any affiliate by any method of communication, including all social media channels.

5.2.10 Bribery

No Player may offer any gift or reward to a player, SLG official, employee, or person connected with or employed by another SLG team for services promised, rendered, or to be rendered in defeating or attempting to defeat a competing team.

5.2.11 Noncompliance

No Player may refuse or fail to apply the instructions or decisions of SLG officials.

5.2.12 Match-Fixing

No Player may offer, agree, conspire, or attempt to influence the outcome of a game or match by any means that are prohibited by law or these rules.

5.2.13 Document or Miscellaneous Requests

Documentation or other reasonable items may be required at various times throughout MOONJAM as requested by SLG officials. Penalties may be imposed if the documentation or items requested are not received and/or completed at the required time or do not meet the standards set by SLG officials.

5.3 Association with Gambling

No Player or SLG official may take part, either directly or indirectly, in betting or gambling on any results of any tournaments or matches globally.

5.4 Prohibition of Solicitation or Sale of Goods

Players are prohibited from soliciting any service or selling any goods during the MOONJAM Tournament.

5.5 Commercial Use of Super League Gaming/Minecraft Assets and Imagery

Players are prohibited from any commercial use of Super League Gaming, MOONJAM, Minecraft, Assets and Imagery without the express, written consent of Super League Gaming, MOONJAM officials, or Mojang, respectively. Personal use of Super League Gaming imagery and assets, including on social media, is allowed and specifically subject to the Player Conduct rules above, including but not limited to no harassment, sexual harassment or disruptive behaviour.

5.6 Subjection to Penalty

Any person found to have engaged in or attempted to engage in any act that SLG believes, in its sole and absolute discretion, constitutes unfair play, will be subject to penalty. The nature and extent of the penalties imposed due to such acts shall be in the sole and absolute discretion of SLG officials.

5.7 Penalties

Upon discovery of any Player committing any violations of the rules listed above, MOONJAM Officials may, without limitation of its authority under Section 8, issue the following penalties:

- 5.7.1 Official Warning
- 5.7.2 Prize Forfeiture
- 5.7.3 Suspension

5.7.4 Disqualification

5.8 Penalty Schedule

Repeated infractions are subject to escalating penalties, up to, and including, disqualification from participation in MOONJAM. It should be noted that penalties may not always be imposed in a successive manner. SLG Officials, in their sole discretion, for example, can disqualify a player for a first offense if the action of said player is deemed egregious enough to be worthy of disqualification by SLG officials.

5.9 Right to Publish

SLG Officials shall have the right to publish a declaration stating that a player has been penalized. Any players which may be referenced in such declaration hereby waive any right of legal action against MOONJAM, Super League Gaming, Mojang, and/or any of their parents, subsidiaries, affiliates, employees, agents, or contractors.

6.0 Spirit of the Rules

6.1 Finality of Decisions

All decisions regarding the interpretation of these rules, player eligibility, scheduling and staging of MOONJAM, and penalties for misconduct, lie solely with SLG officials the decisions of which are final. MOONJAM decisions with respect to these rules cannot be appealed and shall not give rise to any claim for monetary damages or any other legal or equitable remedy.

6.2 Rule Changes

These rules may be amended, modified or supplemented by SLG officials, from time to time, in order to ensure fair play and the integrity of MOONJAM.

6.3 Best Interests of SLG

SLG officials at all times may act with the necessary authority to preserve the best interests of SLG. This power is not constrained by lack of specific language in this document. SLG officials may use any form of punitive actions at their disposal against any entity whose conduct is not within the confines of the best interests of SLG.

7.0 Other

7.1 Binding Effect.

By submitting your entry, you agree to be bound by these Official Rules and failure to comply with these Official Rules may result in disqualification. All federal, state and local laws apply.

7.2 Publicity Release

Except where prohibited by law, acceptance of a prize shall constitute the Winner's agreement with Super League Gaming may to use their name, address, voice, likeness and prize information for promotional purposes without further payment or compensation, unless prohibited by law.

7.3 Privacy; Data Collection

7.4 Promoter

7.5 List of Winners

Residents of Vermont may omit return postage.

7.6 General Release

To the extent permitted by applicable law, MOONJAM Officials, Participating Partners, and each of their respective parents, affiliates, subsidiaries and advertising and promotion agencies (collectively, "Tournament Entities"), and all of their respective officers, directors, agents and employees will not be responsible for any of the following insofar as they are beyond their reasonable control: (a) technical failures of any kind, including, but not limited to telephone, electronic, hardware, software, network, Internet, or any other computer and communications related malfunctions or failures; (b) any Tournament disruptions, injuries, losses or damages caused by events beyond the control of MOONJAM Officials with the exception of personal injury or death caused by negligence; or (c) any technical or human error such as typographical, printing, or administrative errors in any materials associated with the Tournament. Unless prohibited by applicable law, Players acknowledge that the prizes will be awarded "as is" and that neither MOONJAM Officials nor Riot Games make any warranty, guarantee or representation of any kind, expressed or implied, concerning a prize or regarding the use, value or enjoyment of the prize.

By entering the Tournament, Players agree to release, discharge, indemnify, and hold each of the Tournament Entities, and each of their officers, directors, employees, agents and representatives, harmless from and against any and all losses, damages, rights, claims, and actions of any kind arising in whole or in part, directly or indirectly, from the Tournament or participation in any Tournament-related activity (including, without limitation, travel to/from such activity), or resulting directly or indirectly, from acceptance, possession, use, or misuse of any prize awarded in connection with the Tournament, including, without limitation, personal injury, death, and/or property damage, as well as claims based on publicity rights, defamation, and/or invasion of privacy.

7.7 General Terms

To the extent permitted by applicable law, the Tournament and these Official Rules will be governed, construed and interpreted under the laws of the state of California, USA. The Tournament is subject to applicable federal, state, provincial and local laws and regulations.

Players agree to be bound by these Official Rules and by the decisions of the MOONJAM Officials, which are final and binding in all respects.

SLG officials reserve the right to cancel, suspend, and/or modify the tournament, or any part thereof, if any fraud, technical failures, or any other factor beyond SLG official's reasonable control impairs the integrity or proper functioning of the Tournament, or SLG officials otherwise becomes incapable of running the Tournament as planned, as determined by SLG officials in its sole discretion. SLG officials reserve the right in its sole discretion to disqualify any individual found to be tampering with the entry process or the operation of the tournament, or to be acting in violation of these official rules or acting in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Tournament may be a violation of criminal and civil law, and, should such an attempt be made, SLG officials reserve the right to seek damages from any such persons to the fullest extent permitted by law. SLG official's failure to enforce any terms of these official rules shall not constitute a waiver of that provision.

7.8 Disclaimer

SUPER LEAGUE GAMING DOES NOT MAKE ANY REPRESENTATIONS OR WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED, REGARDING ANY PRIZE OR YOUR PARTICIPATION IN THE PROMOTION.
