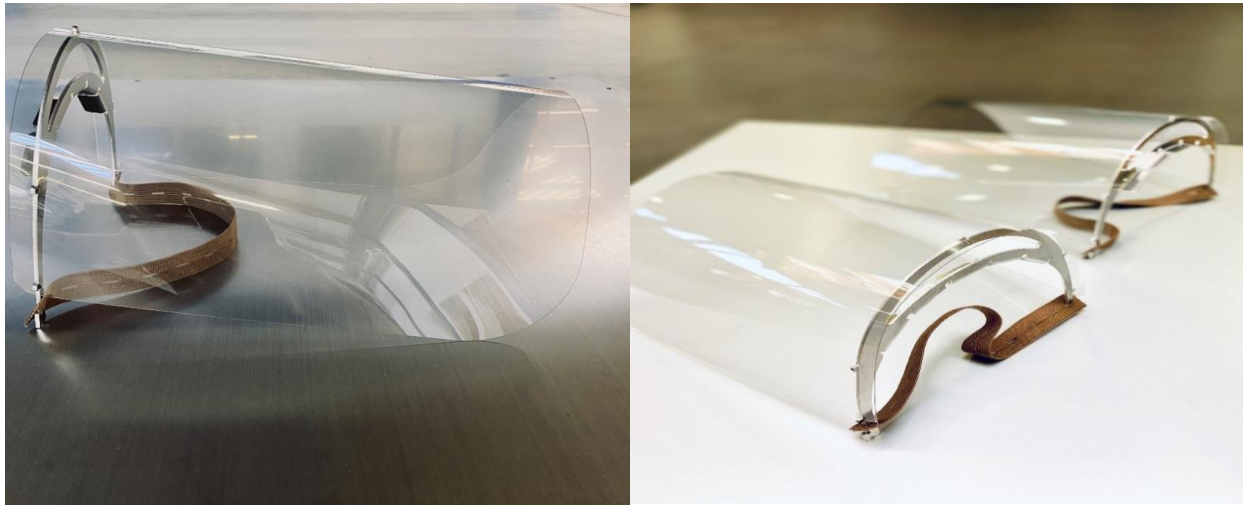


Face SHIELD



Classification	Category I based on regulation (EU) 2016/425 for personal protective equipment (PPE).
Product description	Non-reflective face shield, which offers almost complete face protection against drops and splashes.
Materials	<p><u>Visor:</u></p> <ul style="list-style-type: none"> • Clear 240mm x 330mm face shield • PET film shield • Visor thickness: 0,3 mm <p><u>Headboard:</u></p> <ul style="list-style-type: none"> • Aluminum bracket and self-adhesive foam tape • Elastic perforated rubber band made of fabric <p>Product weight: 67 Grams</p>
Area of application/ intended use	The face shield is therefore suitable for a variety of uses in public life and offers protection against drops and splashes.
Quality criterion	<p><u>Visor:</u></p> <ul style="list-style-type: none"> • The PET-film shield ensures a sight free of distortions and thus does not create a feeling of dizziness. • The rounded corners allow free head movement. • The simple latch of the visor enables its unproblematic removal, cleaning (if necessary) or exchange.

	<ul style="list-style-type: none"> The space between visor and face allows wearing respiratory masks or glasses. <p><u>Headboard with rubber band:</u></p> <ul style="list-style-type: none"> The rubber band allows easy adjustment of the head width and therefore can be used for every head width and shape. The foam tape ensures a pleasant wearing comfort.
Packaging unit	The aluminum bracket, foam tape and rubber band are packed in one small all-purpose bag, which is in turn packed in another all-purpose bag together with the visor.
Storage	The face shield should be stored in the original packaging in dry surroundings without sun exposure.
Disposal	Please observe the applicable national disposal regulation in your country.
Restriction of use	<ul style="list-style-type: none"> Do not change or modify the face shield. Only use the product for the areas of applications mentioned above. Follow the operating instruction of this product before first using it.

Protection against burning, disintegrating substances, or substances dissolving through thermal impacts like acids, light sources, gases, or vapors of any kind. Protection against sparks, radiation or ultraviolet rays. While smoking or during every activity with or close to flames or heat-emitting devices.
