- That eye protection and/or other safety equipment provided is always to be worn within the gaming arena;
- I understand that failing to comply with any rules stated verbally by Darts & Blasters, LLC employees, as well as written documents explaining rules and safety requirements will result in Darts & Blasters, LLC, having to eject participants from the event and no refunds will be offered;
- That as a Darts & Blasters, LLC event host, I and designated volunteers from my organization must always follow the instructions of my Darts & Blasters, LLC attendant, and work with Darts & Blasters, LLC to ensure that all participants follow game rules and safety requirements, and if I or any participants in my group engage in unsafe or inappropriate behavior, Darts & Blasters, LLC reserves the right to ask participants to leave and/or to terminate the game or event and no refunds will be offered;
- As an event host, I/we must assist Darts & Blasters, LLC in supervising participants and instructing participants not to climb on any of the structures or buildings within the gaming arena;
- I/we must not consume any alcohol or intoxicating substances prior to or during the session or activity;
