<a href="#">What is the overall deductible?</a>	\$3,000 / self only coverage or \$6,000 / family coverage in-network. \$6,000 / self only coverage or \$12,000 / family coverage out-of-network.	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , the overall family <a href="#">deductible</a> must be met before the <a href="#">plan</a> begins to pay.
<a href="#">Are there services covered before you meet your deductible?</a>	Yes. <a href="#">Preventive services</a> in-network are covered before you meet your <a href="#">deductible</a> .	This <a href="#">plan</a> covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount. But a <a href="#">copayment</a> or <a href="#">coinsurance</a> may apply.
