OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

1. PREAMBLE:

This NGRAVE Sweepstakes (“Sweepstakes”) is administrated by NGRAVE.io (“the Administrator”), registered at Kloosterstraat 94, 2000 Antwerp, Belgium.

By participating in the Sweepstakes, each participant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the Administrator, which shall be final and binding in all respects. Administrator is responsible for the collection, submission or processing of participants and the overall administration of the Sweepstakes and for distribution of prizes to eligible winners. Participants should look solely to the Administrator with any questions, comments or problems related to the Sweepstakes. Administrator may be reached by email at contest@ngrave.io during the Entry Period.

The administrator may change these Official Rules if the reasons for this are of technical or commercial nature. Participants will be made aware of any changes to the Official Rules with a notification on the Sweepstakes registration page.

2. ELIGIBILITY:

Citizens, nationals, residents (tax or otherwise), green card holders and/or Restricted persons of any Restricted Jurisdiction are not permitted to participate and are expressly prohibited from participating in the Sweepstakes.

The term “Restricted Jurisdictions” means and includes: (1) the Federative Republic of Brazil; (2) The Republic of India; (3) the Italian Republic; (4) Spain; or (5) any other jurisdiction which prohibits or requires any supervision, oversight, licensing, and/or any regulatory or legal compliance approval from any regulatory (or similar) authority or body or form for participation in the Sweepstakes.

The term "Restricted persons" refers to any firm, enterprise, partnership, trust, corporation, entity, government, state or agency of a state or any other incorporated or unincorporated body or association, association or partnership (whether or not having separate legal personality) that is established and/or lawfully exists under the laws of a Restricted Jurisdiction.

The Sweepstakes is open to natural persons who are over or eighteen (18) years of age. No one under eighteen (18) years of age may participate in the Sweepstakes.

The administrator, and their respective parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies and each of their respective officers, directors and employees (hereinafter "Promotion Entities"), are ineligible to enter the Sweepstakes or win a prize. Household Members and Immediate Family Members of such individuals are also not eligible to enter or win. "Household Members" shall mean those people who share the same residence at least three months a year. "Immediate Family Members" shall mean parents, step-parents, legal guardians, children, step-children, siblings, step-siblings, or spouses.

The Sweepstakes is subject to all applicable federal, state and local laws and regulations and is void where prohibited or restricted by law.

3. ENTRY PERIOD

The Sweepstakes begins on April 28, 2020 at 13:00 CEST and ends on May 23, 2020 at 13:00 CEST ("Entry Period").

4. PRIZE

A total of ten (10) NGRAVE ZERO & GRAPHENE bundles will be distributed between five (10) eligible participants. Each bundle consists of one (1) NGRAVE ZERO hardware wallet and one (1) NGRAVE GRAPHENE cryptographic key storage and recovery solution.

The prize is limited to one per person. The estimated retail value ("ARV") of the prize is \$0 total and \$0 per each prize.

Each prize is awarded "as is" and with no warranty or guarantee, either express or implied, by the Administrator. Winner is responsible for any federal, state and local taxes, if applicable.

Prizes cannot be transferred, redeemed for cash or substituted by the winner. The Administrator reserves the right in its sole and absolute discretion to award a substitute prize of equal or greater value if a prize described in these Official Rules is unavailable or cannot be awarded, in whole or in part, for any reason. The ARV of the prize represents the Administrator's good faith

determination. That determination is final and binding and cannot be appealed. If the actual value of the prize turns out to be less than the stated ARV, the difference will not be awarded in cash. The Administrator makes no representation or warranty concerning the appearance, safety or performance of any prize awarded. Restrictions, conditions, and limitations may apply. The Administrator will not replace any lost or stolen prize items.

5. HOW TO ENTER:

During the Entry Period, visit the Sweepstakes page located on the Administrator's website at <https://giveaway.ngrave.io> and follow the instructions to electronically complete and submit the Sweepstakes entry form.

You must complete all required fields of the entry form with information that is valid on the date of the drawing to be eligible. Some sweepstakes entries are optional. Each optional entry provides the entrant an additional submission in the drawing process.

Each participant in the game guarantees that the sent data is genuine. Administrator reserves the right to exclude and render any participant's entry void when under doubt of the validity of sent data.

6. LIMITATIONS ON ENTRIES

Automated or robotic entries submitted by individuals or organizations will be disqualified. The internet entry must be made by the participant. Any attempt by participants to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations, logins or any other methods, including, but not limited to, commercial contest/sweepstakes subscription notification and/or entering services, will void participants entries and that participant may be disqualified. Final eligibility for the award of any prize is subject to eligibility verification as set forth below. All Entries must be submitted by the end of the Entry Period in order to participate. The Administrator's database clock will be the official timekeeper for this Sweepstakes.

7. DRAWING

Winners will be selected in a random drawing from among all eligible participants collected during the Entry Period. All submissions will be numbered ascendingly based on the chronological order of their input. Ten (10) random numbers will be generated to correspond to the numbered submission which represents the winning entry. The service Gleam.io will be used to generate these random numbers, with the range of 1 – N, where N represents the total number of received submissions.

The drawing will be conducted by the Administrator, whose decisions and interpretations are final and binding in all respects. The random drawing will be conducted within seven (7) days after the Entry Period. The Administrator reserves the right to disqualify any participant or winner and may refuse to award a prize to a person who is not eligible or has violated a rule, gained an unfair advantage in the Sweepstakes, or obtained winner status using fraudulent means. The prize will be awarded to the natural person to whom the email address is assigned by the internet service provider, responsible for the domain associated with the submitted email address. If a winner is found to be ineligible or not in compliance with the Sweepstakes rules, the winner will be disqualified and an alternative winner will be awarded the prize in a separate random drawing.

8. ODDS

Odds of winning will vary depending on the number of eligible entries received, according to the eligibility requirements in the Sweepstakes.

9. DISTRIBUTION OF PRIZES

The prize will be sent to the winners physical address of choice via a postal service. Winners will be asked to provide said address when contacted by The Administrator in the winner notification e- mail.

The prize's estimated time of delivery is October 2020. The estimated time of delivery is not binding and the prize may be delivered before or after October 2020. In the event the prize for any reason cannot be delivered, including, but not limited to: bankruptcy, liquidation, dissolution, production issues, supply chain issues or other force majeure, The Administrator are absolved from any obligation to deliver the prize to the winner.

In the event an eligible winner provides erroneous, inaccurate or incorrect information of his own fault, and the prize is unable to be delivered correctly as a direct result of such fault, the prize will be considered to be delivered and further disputes are not possible.

10. WINNER NOTIFICATION:

Winners will be notified by email address within four (4) days of winner selection by The Administrator. The winner must accept the prize by email as directed by The Administrator within five (5) days of notification. Any winner notification not responded to or returned as undeliverable may result in prize forfeiture. Inability of The Administrator to contact winner by email address within seventy-two (72) hours after winner selection may result in disqualification

of winner and an alternate winner may be selected in a random drawing at Sponsor discretion. The Administrator is not responsible for any delay or failure to receive notification for any reason, including inactive email account(s), technical difficulties associated therewith, or winner's failure to adequately monitor any email account.

The potential prize winner may be required to sign and return an affidavit of eligibility and release of liability. No substitution or transfer of a prize is permitted except by The Administrator.

11. PRIVACY:

Information collected from entrants is subject to The Administrator's privacy policy available at <https://www.ngrave.io/privacy-policy>.

The provision of sent data is voluntary. If a participant does not wish to disclose data that is considered mandatory for the execution of the contest, he may not participate in the contest.
