
Project Narrative

The use of data is transforming the world. The way the Federal Government provides, maintains, and uses data has a unique place in society, and maintaining trust in federal data is pivotal to a democratic process. The Federal Data Strategy sought use cases from the public that solve problems or demonstrate solutions that can help inform the four strategy areas: Enterprise Data Governance; Use, Access, and Augmentation; Decision-making and Accountability; and Commercialization, Innovation, and Public Use.

The Council Exchange Board of Trade, National Minority Technology Council (Council) submitted a Use Case that is now part of the Federal Data Strategy Use Case portfolio. This Integrated Economic Indicator (IEI) Use Case utilizing the State Longitudinal Data System (SLDS) or (ISI-SLDS) affords the contemplation of a national data harmonizing effort to bring together the disconnected "Social Safety Net" here in America into a transformational predictive system that allows for better policy decision making and innovation, in areas that help put American's to work. The Council ISI-SLDS use case illuminates that algorithms that link calculated datasets as predictive exchanges will soon prove the value of smart contracts, governed workflow and merit-based entitlement payout systems focused on outcomes rather than outputs.

The assignment is to provide the Council technical, research, procurement, and design support for the new enterprise instance now being set up at the Norfolk State University Cyber Security Complex located in Norfolk Virginia.
