The information gathered through these cookies is used for measuring the activity of web sites, applications or platforms and for profiling user navigation on such sites, applications and platforms, in order to make improvements based on the analysis of data of users who use the service.

3.3. We use 'Advertising cookies' to support our Website. We will send these advertisers information including your IP address, the time at which you visited the website, the browser you used to visit our Website, the unique ID number the cookie has given your browser, and in some cases, whether you have a Flash installed. These are used to tailor the ads to the you localisation and/or general preferences, thereby tempting to prevent showing irrelevant ads or ads you may have already seen.

3.4. We will not share personal information collected from our cookies with any third party except as set out in this Cookies Policy
