## **Photo Contest Rules**

**TO ENTER:** The Contest may only be entered online by posting on <a href="www.instagram.com">www.instagram.com</a> and tagging it with #MyACEvolution for the ["ACE 35th Anniversary"] Contest. From Instagram, post 1 photo/video from the beginning of your fitness career and 1 photo/video from the past 6 months of your fitness career (the "entry") and including a caption that describers your experience with ACE throughout your career[description]. One entry per person.
