The legal basis for the processing of your personal data is Art. 6 (1) (a) of the GDPR - the data subject has given consent to the processing of their personal data for one or more specific purposes, in this case for use in our Huawei Ireland - University Challenge 2021 Retention Period

Your personal data which is processed in order to allow you to participate in our **Huawei Ireland - University Challenge 2021** will be retained for a period of **3 months**. It will then be deleted, unless necessary to comply with a legal obligation on the Controller. The reason for the 3 months retention is that the online registration will start on 06th November and the closing ceremony will be on 22nd December. After the ceremony, Huawei would need the information to delivery prize to students, which might take another month. Thus, Huawei would like to retain the information for at least 3 months.

Disclosure of Personal Data

Your data will only be processed within the EEA. Your data will be processed on behalf of Huawei Technologies (Ireland) Co., Limited by BeMyAPP SAS, a company incorporated under the laws of France, whose registered office is at 18 boulevard Michelet, 13008, Marseille. They will process your data only on documented instructions from Huawei Technologies (Ireland) Co., Limited under a contract which ensures that thet are GDPR compliant.

Your Rights:

You have the rights to obtain the following from Huawei:

- confirmation of the processing or non-processing of personal data concerning you and, where applicable, access to a copy of personal data and specific information on how Huawei processes personal data;
- rectification of inaccurate personal data concerning you and also the right to complete incomplete personal data;
- deletion of your personal data, in particular circumstances;
- restriction of processing, in certain circumstances;
- data portability, in certain circumstances.

You also have the right to:
