Here at ClearFreight, we are committed in your success. While we continue to closely monitor current global situations due to the COVID-19 pandemic, we would like to share below updates with you:

United States

NY

- U.S. Customs and Border Protection's (CBP) New York Field Office released a [memo](#) stating that effective immediately, importers or their agents are encouraged to provide advance notification to CBP when they are expecting shipments of pandemic relief materials, whether that includes pharmaceutical products, personal protective equipment, building supplies, or other items. This includes shipments in the air, on the water, or already arrived and pending release, and is particularly true for shipments CBP has placed on hold. This action will help CBP expedite legitimate shipments of relief materials while taking appropriate enforcement action against nefarious actors.

BAL

- The Seagirt Marine Terminal at the Port of Baltimore will be closed on Monday, March 30 and Tuesday, March 31.
 - Gate hours will be 6:00AM to 4:45PM from Wednesday, April 1 through Friday, April 3.

MIA

- POMTOC will be closed on Monday 03/30 due to extremely low import volumes caused by blanked vessel sailings.
- POMTOC will be closed on Friday 04/10 in observance of Good Friday.

- By direction of ZIM Line, the POMTOC Gate will be closed to receiving ZIM 20' dry empty returns. These empties are to be returned to SFCT (effective Wednesday 03/18).
- Port Everglades will close on Thursdays weekly until further notice.

India

- The Prime Minister of India has announced a complete country lockdown from March 25th for a period of 21 days. During this time all essential services (such as food suppliers, hospitals, banks etc.) will remain open. Airports and seaports remain open though with very limited staff. Transporters/Customs Brokers/warehouses will be closed.

The Netherlands

- No more group events of more than 2 people (fine EUR 400 - private individuals / EUR 4000 - companies).
- Stay home and keep at least 1.5 meters away from other people (including family members)
- If one family member has a fever, the rest of the family needs to stay home.
- Gatherings of any size will be suspended until June 1.
- Crowd control at storefronts to prevent too many people inside each store.

- Hair & beauty salons as well as casinos are closed until April 6th.
- Theme- and holiday parks closed until further notice.
- Public areas such as beaches & parks are closed.
- Work from home if possible.
- Can be outside only for essential activities such as groceries/medicine/doctor's visits.
