India - Coronavirus

As a consequence of COVID-19 crisis, India government on 24th Mar imposed a nationwide lockdown from 25th Mar on residents living across the country for 3 Weeks to be under travel, work and movement restrictions.

In-country Air & Road movement is suspended by the authorities.

UPS India has at this moment only Delhi Gateway/Hub Operations open, on road delivery and pick up operations are suspended.

The UPS flight is operating to/from Delhi as normal. Customers can bring their volume to our Delhi Gateway and Export their goods through our air network.

As from 26 March 2020, the Government of Kenya has put a ban on all international flights in order to contain the Coronavirus spread, resulting in export/import delays.

UPS in Kenya is still operational, making pickups and deliveries.

However the Kenyan Government has announced that there will be a curfew imposed from 19.00-05.00 starting on 27 March 2020. There will therefore be delays on pickups and deliveries.

On March 19 2020, the President of Algeria declared a state of emergency and suspended all passenger flights. Only cargo flights can fly in/out of country. UPS continue to import and export volume. However, the current flights are operating only twice a week, resulting in import/export delays. All deliveries must be completed by 15:30 and pickups are done with a short cut-off time to respect the state of emergency.

While UPS is maintaining service, pickup and deliveries are subject to delays.

France-Coronavirus

This is a follow-up to Message number 11054.

Effective Saturday March 14th until April 15 2020, French authorities have put France on stage 3.

Shops, coffees shops, restaurants and commercial centers are closed until April 15th.

Domestic and transborder shipments that cannot be delivered due to the closure of a retail location will be returned to the shipper on the same day. For international and EU transborder F/C only shipments, the ERN process will apply.

The below RTS procedure concerns only the Retail B2B locations. The B2B enterprises are considered open and delivery attempts are made although most of them have closed of their own will. B2C deliveries go as normal.

For any retail consignee which should not be open as they are not considered essential, an immediate RTS will be made.

For any B2B consignee (retail or non-retail) that is found to be closed while attempting a delivery, an immediate RTS will be made. For WW shipments the ERN process will be followed according to the normal process.

List of open official open retail locations:

Hospitals, Food stores in general including groceries, Gas stations, Pharmacies, Tobacco and press shops, Pet food stores, Dry cleaning, Vapo stores, Banks, Garages, Hotels, Computer repairs and DIY / Do It Yourself / Hardware stores.

In a general way : everything is essential for the everyday life. But we need to be careful : all these categories could be opened but some closed their activity due to lack of employees . Schools and child cares are closed : lot of people are at home babysitting.

Companies are working but slowly as teleworking is recommended for a lot of people.
