

United States

Over 38 states, 48 counties, and 14 cities have stay-at-home / shelter-in-place orders. Click on below map to see how each state

Mexico

Mexico has declared a national public health emergency, effective March 31. All companies that do not provide essential activities must suspend operations until April 30. Essential activities can be classified as follows:

- Workers necessary to respond to the health emergency.
- Law enforcement and public protection.
- Essential sectors of the economy: financial, tax collection, distribution and sale of energy, gas and gas stations, generation and distribution of drinking water, food and non-alcoholic beverage industry, food markets, supermarkets,

convenience stores, sale of prepared food; services of transportation of people and cargo; agricultural and fish products, hardware stores, courier services, telecommunications and media, and activities which could be irreversibly affected if suspended.

- Government welfare programs.
- Activities required for the conservation, maintenance and repair of critical infrastructure necessary for the production and distribution of essential services.

Vietnam

- Nationwide social-distancing campaign started on April 1 to last for 15 days. The campaign includes keeping a safe distance within the community and among people.
- The country will ensure circulation of goods especially the manufacturing of essential goods and medical equipment/supplies continue without interruptions.
- Any cross-border activities between Laos and Cambodia are restricted at this time.
