Service Disruption Details: **As a consequence of COVID-19 crisis, the national lockdown imposed by government authorities in India has now been extended to 3 May 2020. The Government of India (GoI) has classified Courier Industry as essential services with effect from 20 Apr 2020 and allowed the movement of all goods.**

The Government has classified districts across India into COVID-19 zones, each with its own set of guidelines. Depending upon the zone; there may be restrictions on people and vehicle movements. These zones are subject to change depending upon local state guidelines. Our pickup and delivery services will be operational in postal codes across cities in India in line with this advisory.

Customers in restricted zones may experience delays and can chose to self-drop & self-collect shipments at the nearest UPS drop-off locations with appropriate local approvals. Contact India Customer Service for information on specific cities.
