### Today's All Stations Messages

#### China - Labor Day Holiday

2020 China Labor holiday will be observed from May 1, 2020 (Friday) to May 5, 2020 (Tuesday), impacting the UPS service schedule in China as following:

- May 1 to May 4: All cities will close
- May 5: Suzhou, Ningbo, Shanghai, Wuxi, Yiwu, Shenzhen, Dongguan, Guangzhou will open with limited postcode
- May 6: All services back to normal

#### China - Export of Non-Medical Masks

Effective April 26, 2020, the General Administration of Customs of China (GAC), the Ministry of Commerce (MOFCOM), and the General Administration of Market Supervision (GAMS) introduced new requirements for the export of non-medical masks out of China.

Under the new requirements, if the Manufacturer of the non-medical masks to be exported is included in a White List maintained by the China Chamber of Commerce for Import & Export of Medicines and Health Products (CCCIEMHP), a hard-copy Joint Declaration of the Importer and Exporter stating that the non-medical masks to be exported comply with Chinese or destination quality standards needs to be provided during shipment pick-up or tender.

Non-medical masks cannot be exported if the Manufacturer is included in a Black List maintained by GAMS.

If the Manufacturer is not in the Black List and the White List, the Exporter of Record needs to provide during shipment pick-up or tender a hard-copy Joint Declaration of the Importer and Exporter stating that the non-medical masks to be exported comply with Chinese or destination quality standards.

Shippers should ensure that all shipment information provided is accurate and complete for export declaration. UPS will not be responsible for delays or regulatory issues resulting from false declaration of shipments.
