### Latvia-Coronavirus

Following the decision to operate a quarantine regime in Latvia with an end date of 12 May 2020, the Latvian Cabinet of Ministers issued prolongation of **the State of Emergency in Latvia due to Covid-19 until 9 June 2020.**

Cultural, leisure, education, entertainment and sports establishments will operate within a limited time frame, therefore, deliveries and/or pick-ups are also possibly limited at such addresses.

**From 12th May, shopping centres will be opened with reduced time of operation.**

Whenever possible, UPS is trying to re-address packages based on consignee instructions and if required to use Driver Release option. **For COD deliveries, receivers are notified proactively by phone/email to minimize cash flow. Restrictions on the entry of all foreign tourists and visitors coming in from countries that are most affected with COVID 19 virus have been applied.**
