Hong Kong Capacity

Hong Kong Updates:

UPS

- HK-US pick up threshold is at 300kg for both EPP and EFC
- . HK-EU pick up threshold is at 300kg for both EPP and EFC
- HK-IA (excluding JP) pick up threshold is at 300kg for both EPP and EFC
- JP pick up threshold is at 100kg for both EPP and EFC

Taiwan:

UPS

TW to US threshold for general customers

- GWT 300kg EPP & EFC on Express/Saver
- GWT 25kg EPP & EFC on Expedited
- GWT 300kg EPP & EFC on WWEF, while uplift is subject to flight space availability

Vietnam:

UPS

VN to US/Americas/EU/ISMEA

- GWT of 100kg for PPE for both EPP and EFC
- GWT of 1,000kg for all other for both EPP and EFC

Buying extra capacity:

- You would pay your contract rate up to the capacity level and then you would receive an additional fee for the additional amount.
- For example let's say your agreement put your per kilo rate at \$X and the capacity is 100 kilos.
 - You would pay \$X for the first 100 kilos.
 - Then let's say you need another 200 kilos to go out that same day, you would pay \$Y for that additional 400 kilos. If you can ship on multiple days, and keep your shipment under the capacity that can also work.

Things to keep in when deciding to buy extra capacity or spread your shipment out over several days:

- What is the value of your goods? If you are over the \$800/shipment de minimis, there will be the disbursement fee of 2% with a minimum of \$12.
- If you have a government fee such as an FDA clearance you will get the \$25 FDA fee on each shipment.

Jersey and Guernsey are affected by COVID 19 measures as the inbound flight on a daily basis from United Kingdom is delayed (standard time of arrival 07.00 now arriving estimated time of arrival 11.15) so the UPS ASC is having to roll over air volumes daily.

In addition, the export flight has been cancelled, so all volume now goes by boat and all express volume has 1 day extra in transit.
