## Aafaq Platinum Credit Card Complimentary Valet Parking –



### Offer Description

#### Aafaq Platinum Credit Card

Cardholders are entitled to **two (2) complimentary standard valet parking services per calendar month** at selected locations across the UAE, provided through authorized third-party service providers.

#### Aafaq World Elite Credit Card

Cardholders are entitled to **unlimited complimentary standard valet parking services** at selected locations across the UAE, provided through authorized third-party service providers.

### Eligibility Criteria

- Platinum Cardholders must achieve a **minimum retail spend of AED 5,000** in a **calendar month** to qualify for the complimentary valet parking benefit.

*For Existing Customers, the new minimum spends requirements will be effective from 01<sup>st</sup> Aug 2025.*

- Qualifying retail spend includes **Point-of-Sale (POS)** and **E-Commerce** transactions only.
- The following are **excluded** from the spend calculation: balance transfers, cash-on-call transactions, fees, and charges.

### Charges for non-eligibility

- If the Cardholder does not meet the minimum spend requirement, a **fee of AED 100 Plus 5% Vat Fee per visit** will be charged to the Cardholder's subsequent Aafaq Credit Card statement.
- Visits exceeding the two (2) complimentary visits per month will also be charged at **AED 100 Plus 5% Vat Fee per visit**.

### Service Conditions

- The valet parking benefit is applicable **only during the operational hours** of the respective service providers.
- The offer is limited to **standard valet parking services** only. Any **premium or VIP valet services** or **additional parking charges** must be borne by the Cardholder.
- The service is **subject to availability** at the time of arrival at the designated locations.
- Locations may be **added or removed** at the discretion of Aafaq Islamic Finance or the service provider without prior notice.
