



## FAMILY QUESTIONNAIRE

While we process your Green Card application, we want to remind you of the two options available for your family members. Carefully read the options listed below and decide which option fits best for you and your family.

Please complete this Family Questionnaire and return it to your agent within fifteen (15) days.

**If we do not receive your information within fifteen (15) days, we will automatically enroll you in Option A and assume you have selected not to obtain Green Cards for any of your family members.**

Remember, only your spouse (legally married) and unmarried children under the age of 21 can be included in your Green Card application.

### OPTION A - DO NOT INCLUDE FAMILY MEMBERS

*Choose this option if you intend to immigrate to the USA alone.*

Under this option, your family members will NOT be included in your Green Card application process, and they will NOT obtain a Green Card. You will be unable to add them to the process at a later time without incurring significant delays and additional expenses.

Your family members can visit you in the USA if they apply for a tourist visa. However, they will not be able to permanently relocate to the USA without first obtaining a Green Card.

### OPTION B - INCLUDE FAMILY MEMBERS

*Choose this option if you would like your family members to obtain a Green Card and join you in the USA within six (6) months from the Consulate visit.*

Under this option, you and your family members will be processed at the same time. Complete documentation and payment are required thirty (30) days from DOL approval. However, you must travel by yourself, and your family members may join you within six (6) months from the Consulate interview.

Your family members must travel to the USA within six (6) months of their Consulate approval. Otherwise, their Green Card will be CANCELLED.

### OPTION FJ - INCLUDE FAMILY MEMBERS ("FOLLOW TO JOIN")

*Choose this option if you would like to request to process your family members once you have arrived to the USA.*

Under this option, you will receive your Green Card and immigrate by yourself. Then, once you settle into your new job, start earning a good income and save enough funds to process your family members' Green Cards, you may contact us and request that we finalize their Green Card application so they can join you in the USA. This option is called the **"Follow to Join"** process.

You may request we initiate the **Follow to Join** process at any time within the first ten (10) months of your arrival in the USA. Most USA Consulates take approximately 3 to 7 months to schedule **Follow to Join** appointments for family members. However, processing times may vary depending on appointment and Green Card availability in each country. Visa Solutions understands the importance of keeping families together, and for that reason, we prioritize family members' applications at all times.

Once your family members obtain their Green Card, they must travel to the USA within six (6) months of their approval. Otherwise, their Green Card will be CANCELLED.

If you select this option, you do not need to pay anything right now. However, once you initiate the **Follow to Join** process, you will be responsible for all fees and expenses for EACH family member that you wish to include.

## IMPORTANT NOTES

1. If Option B is selected, applicant has thirty (30) days from DOL approval to provide all required documentation and complete payment. Failure to receive all required documents or payment, will result in transferring the cases to Option Follow to Join.
2. Remember to complete your Family Questionnaire and return a legible copy to your Recruitment Agent within fifteen (15) days from today.
3. Make sure your decision is final. Further changes may not be feasible and/or will incur additional expenses or delays.

## SUPPORTING DOCUMENTS FOR OPTION FJ

If you selected Option FJ for any of your family members, you do NOT need to submit any of their documents now. However, you must provide legible copies of the following documents for each applicable family member when you initiate their Follow to Join process:

Passport	For each family member you wish to include
Birth Certificate*	For each family member you wish to include
Police Clearance	From each country in which they have lived for six (6) or more months since the age of 16
Marriage Certificate*	If legally married
Divorce Certificate*	If you have been previously divorced, along with previous Marriage Certificate
Death Certificate*	If your legally married spouse passed away, along with previous Marriage Certificate
