Official Rules  
No Purchase Necessary**

The **Schlage® Holiday Instagram Photo Sweepstakes** (“Sweepstakes”) is sponsored by Allegion Canada Inc, 1076 Lakeshore Road East, Mississauga, Ontario L5E 1E4 (“Allegion Canada”). By entering, each entrant accepts and agrees to be bound by these Official Rules.

This Sweepstakes is comprised of the following components: a.) “Following” Schlage Canada on Instagram @SchlageCanada; and b). posting a photo of participant’s holiday decorated door at their residence to their personal Instagram account using hashtag #SchlageHolidayDoor. Winner will be selected at random if they meet sweepstakes criteria and eligibility.

1. SWEEPSTAKES PERIOD: The Sweepstakes begins on December 5, 2018, 2018 at 9:00:00AM Eastern Time (“EST”) and ends December 19, 2018 at 9:00:00 AM EAT (“Sweepstakes Period”). Note: Allegion Canada’s computer is the official time keeping device for the Sweepstakes Period.
2. ELIGIBILITY: This Sweepstakes is open only to legal residents of Canada, excluding Quebec, who are at least 18 years old at the time of entry and have a valid and active Instagram account. This Sweepstakes shall be construed and evaluated according to the laws of the Province of Ontario. Sweepstakes is void where prohibited or restricted by law. The Sweepstakes is not open to: (a) Employees of Allegion Canada, its parent or subsidiaries, or their respective agents and affiliates, and their family members or persons living in the same households of such individuals; (b) anyone professionally involved in the development or administration of this Sweepstakes; (c) employees or internally contracted vendors of governments and government-affiliated companies or organizations; or (d) any employee whose employer’s guidelines or regulations do not allow entry in the Sweepstakes or acceptance of the prize(s) . By entering this Sweepstakes, participants agree to abide by all terms of these Official Rules and to be bound by the decisions of Allegion Canada. All provincial and local laws apply. Winners will be required to sign and return to Allegion Canada within ten (10) days an affidavit of eligibility (except where prohibited) affirming their agreement to all terms, conditions, and restrictions in these Official Rules.
3. AGREEMENT TO OFFICIAL RULES: Your participation in the Sweepstakes constitutes your full and unconditional agreement to and acceptance of these Official Rules and the decisions of Allegion Canada, which are final and binding. Winning a prize is contingent upon fulfilling all requirements set forth herein in a timely manner.
4. HOW TO ENTER: To enter the Sweepstakes, go to the Schlage® Locks Canada’s Instagram page at [@SchlageCanada](#) during the Sweepstakes Period. To participate, you will be required to “Follow” the Schlage® Locks Canada Instagram page at [@SchlageCanada](#) and post a photo of your home’s holiday door to your personal Instagram account using hashtag #SchlageHolidayDoor. (NOTE: Such posts or photo may not contain profanity or obscene material or content, depict recognizable third party marks, participant’s personal address, copyrights, brands, or other property, unless the entrant has obtained all proper licenses, or promote non-Allegion Canada products or disparage any party in any

way.) If you are a winner of the Sweepstakes, you will receive a message from Allegion Canada through Instagram. Limit one entry per person, household address, email address or IP address for the duration of the Sweepstakes. Duplicate or multiple entries will be disqualified. Use of any automated entry software is prohibited.

5. SWEEPSTAKES JUDGING CRITERIA: Entrants must post a photo of their home's holiday door to their personal Instagram account. Photos must be free of profanity or obscene material or content, participant's personal address, and they may not depict third party marks, copyrights, brands, or other property, unless the entrant has obtained all proper licenses, nor may they promote non-Allegion Canada products or disparage any party in any way. One (1) winner will be chosen at random on December 20, 2018. To be valid, all entries must be received during the Sweepstakes Period. All decisions of Allegion Canada concerning all matters related to this Sweepstakes are final. **Odds of winning depend upon the number of eligible entries received.** A purchase of Allegion Canada's products will not increase the odds of winning. Winners must meet all eligibility requirements. All potential Sweepstakes entries are subject to verification by Allegion Canada, whose decision is final and binding in all matters related to the Sweepstakes. Allegion Canada will not accept screen shots or other evidence of winning in lieu of its validation process. Any entry that occurs after the system has failed for any reason is deemed a defective entry and is void and will not be honoured. If any attempted notification is not successful within ten (10) days, the prize will be forfeited and Allegion Canada reserves the right to randomly select an alternate winner from among the remaining eligible entries.

Grand Prize will include one Schlage® handleset and one Schlage® electronic lock (winner can choose from style and finish based on their preference, subject to availability) and a \$400 Amazon gift card. The Grand Prize will have a total approximate retail value of \$1000.00 Canadian Dollars. The approximate retail values are subject to change based on current market conditions at the time of prize fulfillment. Winners are not entitled to any surplus between actual retail value ("ARV") of prize(s) and stated ARV and any difference between stated ARV and actual value of the prize(s) will not be awarded. Prizes may not be exchanged or redeemed for cash, sold, or traded. No prize transfer, assignment, or substitution by Winners is permitted. Allegion Canada reserves the right to substitute a prize, in which case a prize of equal or greater value will be awarded. Winners will be solely responsible for any and all local, provincial, country or other applicable taxes. Amazon is not a sponsor of this Sweepstakes.
7. HOW TO CLAIM YOUR PRIZE: Reply to the winning message from Allegion Canada that transmitted through Instagram within 10 days after the Sweepstakes ends. The winning message from Allegion Canada will provide you with direction where you will be prompted to complete the prize claim process by providing prize claim details, including executing and delivering the required liability release and affidavit of eligibility. Eligible entrants who are winners and satisfactorily complete the verification process will win the prize indicated, subject to these Official Rules. Winners must comply with all

terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements. Winners of the Sweepstakes prize who meet all of the eligibility requirements, are verified, and have fully complied with these Official Rules, will receive their prize via Canada Post or U.P.S. within approximately eight (10) weeks after the conclusion of the Sweepstakes Period or the prize order, whichever occurs last.

8. **GENERAL CONDITIONS:** Subject to applicable law, Allegion Canada reserves the right to cancel, suspend, and/or modify the Sweepstakes if any fraud, virus or other technical problem corrupts the administration, security, validity, or proper play or for any other reason, as determined by Allegion Canada in its sole discretion. In such event, Allegion Canada reserves the right to award the prize(s) from among the eligible entries received up to the time of the impairment. Allegion Canada reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner.
